### **Disclosure of Personal Information**

- To any social agency providing any form of assistance to me, or other government subsidy under the *Ontario Works Act, 1997*, the *Ontario Disability Support Act, 1997* or the *Day Nurseries Act*, or any government department responsible for social housing programs under the *Housing Services Act, 2011*, or Cornwall and Area Housing Corporation's housing portfolio operating agreement;
- To the Government of Canada, a department, ministry or agency of it, without further notice to me if the information is necessary for the purpose of administering or enforcing the *Income Tax Act (Canada)* or the *Immigration Act*;
- To any agent working on behalf of Cornwall and Area Housing Corporation for the purposes of complying with the *Housing Services Act, 2011*;
- To relevant agencies or next of kin in case of emergency;
- To credit bureaus and other businesses that provide credit or rental history information about me;
- To a third party in connection with the potential or actual sale, reorganization, merger, consolidation or disposition of the business of Cornwall and Area Housing Corporation.
