A By-law to amend the Traffic & Parking by-law 069-1989, Schedule II, Parking Restrictions, Schedule IV, Parking Restrictions-time limits, and Schedule VIII, Parking Meter Zones on York Street

Whereas By-law enforcement and residents brought to the City's attention certain issues regarding on-street parking on York Street.

Whereas the majority of respondents are in favour of the proposed changes.

Now therefore be it resolved that the Council of The Corporation of the City of Cornwall enacts as follows:

Pursuant to Sections 8, 9 & 11 of the Municipal Act and amendments;

Schedule II (Parking Restrictions) of the Traffic & Parking By-law No. 069-1989, and 016-2011 is amended by repealing thereto the following:

Highway	Side	Between	Prohibited Times or Days
York Street	West	53 metres south of First St. West and a point 134 metres further south	Anytime

Schedule IV, Parking Restrictions-time limits, of the Traffic & Parking By-law No. 069-1989, and 176-2003 is amended by repealing thereto the following:

Highway	Side	Between	Restricted Times or Days	Maximum Period Permitted
York Street	West	29 metres north of Water St. West and a point 14 metres further north	Anytime	15 min

Pursuant to Sections 8, 9 & 11 of the Municipal Act, and amendments;

Schedule II (Parking Restrictions) of the Traffic & Parking By-law No. 069-1989 is amended by adding thereto the following:

Highway	Side	Between	Prohibited Times or Days
York Street	West	89 metres south of First St. West and a point 45 metres further south	Anytime


Schedule IV (Parking Restrictions - Time Limits) of the Traffic & Parking By-law No. 069-1989 is amended by adding thereto the following:

Highway	Side	Between	Restricted Times or Days	Max. Period Permitted
York Street	West	28 metres north of Water St. and a point 14 metres further north	Anytime	30 min
York Street	West	69 metres south of First St. West and a point 20 metres further south	Anytime	30 min

Schedule VIII (Parking Meter Zones) of the Traffic & Parking By-law No. 069-1989 is amended by adding thereto the following:

Highway	Side	From	To
York Street	West	A point 15 metres south of First St. West	A point 60 metres south of First St. West

Whereas following concerns about parking received from the residents, parking surveys were sent to residents of First Street between Amelia and Adolphus Street; and


Whereas the majority of the respondent residents support the proposed parking restrictions.

Whereas the majority of the respondent residents support the proposed parking restrictions.





Whereas there is often significant presence of children around the proposed safety zone; and


Whereas community safety zones nearby schools help for the prevention and enforcement of moving violations.


Now therefore be it resolved that the Council of the Corporation of the City of Cornwall enacts as follows:
