

BUSINESS LICENSE

Application *For*

SALESPERSON (RESIDENT)

DEFINITION:

Salesperson shall mean any person who goes from place to place or to a particular place with goods, wares or merchandise for sale or who carries and exposes samples, patterns or specimens of any goods, wares, or merchandise that is to be delivered in the City of Cornwall afterwards. This also includes flea markets.

No such license is required for hawking, peddling, or selling goods, wares or merchandise:

- to wholesale or retail dealers in similar goods, wares or merchandise, or
- if the goods, wares or merchandise are grown, produced or manufactured in Ontario and are hawked, peddled or sold by the grower, producer or manufacturer or its agent or employee having written authority to do so, in the municipality in which the grower, producer or manufacturer resided, or
- if the goods, wares, merchandise are grown or produced by a farmer resident in Ontario who offers for sale or sells only the produce of its own farm, or
- if the goods wares or merchandise are hawked, peddled or sold by an agent of the grower, producer or manufacturer, acting on behalf of a dealer who operates a business within the City of Cornwall and is recognized within the municipal assessment roll as a business operation.
 - i. by persons who sell milk or cream or fluid products to the consumer or to any person for resale, or
 - ii. to persons, organizations, associations or groups who contribute to the enrichment of community life within the City of Cornwall provided that the person, organization, association or group is directly responsible for the retail operation and that all proceeds derived from the sale are used to further the enrichment of community life in the City of Cornwall, or
 - iii. to persons who are licensed under the provisions of the Retail Exhibition Bylaw.

EXAMPLE:

RESIDENT SALESPERSON

License "A" - to a Resident Salesperson who offers for sale goods, wares or merchandise from place to place within the City of Cornwall.

License "B" - to a Resident Salesperson who offers for sale goods, wares or merchandise from a particular place on an intermittent basis.

NON-RESIDENT SALESPERSON

License "C" - to a non-resident sales person who offers for sale goods, wares or merchandise from place to place within the City of Cornwall yearly.

License "D" - to a non-resident salesperson who offers for sale goods, wares or merchandise from a particular place and has not demonstrated the intent to establish the business in a permanent structure within the City of Cornwall. This license shall be valid for a period of thirty (30) consecutive days only, from the date of purchase.

License "E" - to a non-resident salesperson who offers for sale goods, wares or merchandise from a particular place within the City of Cornwall on a yearly basis and has established the business within a permanent structure. The license will be required for the initial year of operation only.
