

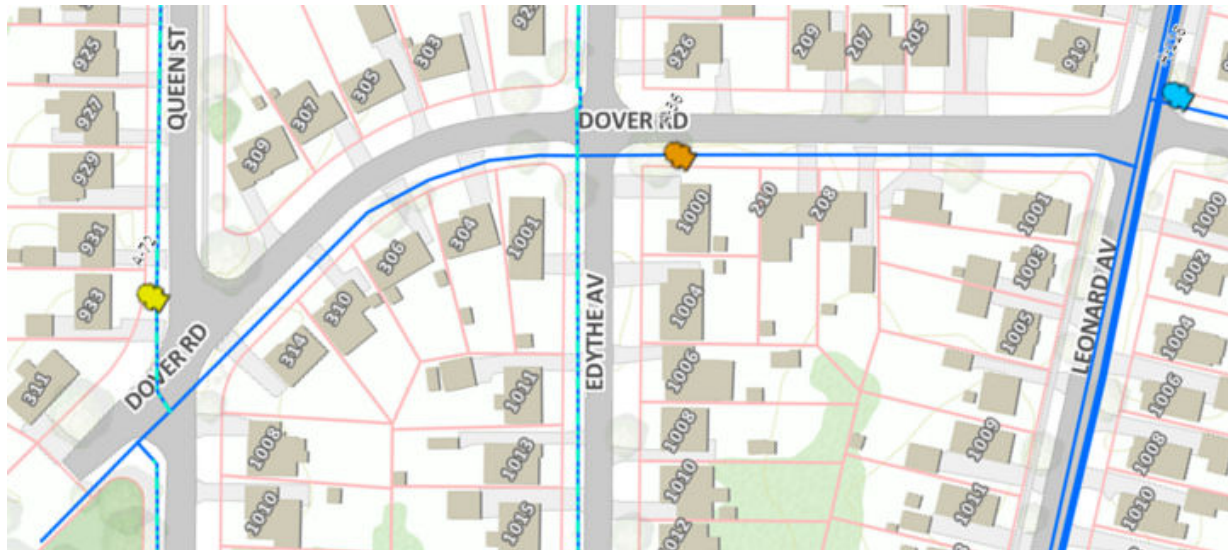
## CONSTRUCTION NOTICE

Tender No.: 24-T13

Location: Dover Rd from Queen St to Leonard Av

Anticipated Start Date: May 27<sup>th</sup> 2024

### Work Details

The City of Cornwall will be undertaking watermain lining in your area starting the week of May 27<sup>th</sup>, 2024. The work will take place on Dover Rd from Queen St to Leonard Av.

### What To Expect During Construction?

- At the onset of construction, you should expect to see the Contractor bring equipment on-site and prepare work areas; you may also see paint marks on the roadway and flags in the boulevard which indicate the location of any buried infrastructure (gas mains, electrical, sewers, etc.).
- The Contractor will then install a temporary water supply system and attach the system to your residence/property. Residents should expect a short-duration disruption to the water supply when switching over to the temporary water system. Notices will be sent to all residences prior to the disruption.
- Work includes the excavation of pits in the road or boulevard to access the existing watermain.
- The Contractor will then clean and structurally reline the existing watermain.
- Once the watermain has been relined, properties will be reconnected to the newly relined watermain; residents will again experience a short-term disruption to the water supply but will be notified prior to the disruption.
- Lastly, the Contractor will remove the temporary water supply piping and restore all work areas with asphalt, concrete, or grass.

	Working Hours - Standard work hours are from 7:00am to 6:00pm, Monday to Friday. Work after hours and on weekends may be required in an emergency
	Water Service Disruptions - There will be times when the water supply is disrupted. This is because the water has to be off in order to connect/disconnect residents to the temporary water supply so that the new watermain can be installed. The Contactor will send out notices twenty-four (24) hours in advance of the water being turned off.
	Accessibility - Residents with accessibility requirements should contact the project team. The City is happy to make any necessary accommodations during construction.
	Traffic Management - Please expect traffic delays during construction. Residents should also expect an increase in traffic on nearby streets.
	Parking - Parking in the active work area is not permitted during construction. Parking will be the responsibility of the property owner. Any vehicles parked in an active work area will be towed if the owner is not available.
	Garbage & Recycling - Please follow your normal routine. If required, the contractor will move bins to an alternate location and return them. Please label your bins with your civic address.
	Restoration - The construction work area will be restored when the work is complete. Lawn seeding and/or laying of sod will take place during the ideal growing seasons only. Either in the Spring (April to June) or Fall (September to October).
