Collection of Personal Information:

The **Housing Services Division** will collect, retain and use the personal information provided by me for the following purposes:

- To determine my initial and ongoing qualification for geared-to-income housing;
- To determine the amount of assistance I am eligible for;

Disclosure of Personal Information

The **Housing Services Division** will disclose personal information provided by me to the following parties for the purposes described above:

- To any social agency providing any form of assistance to me, or other government subsidy under the *Ontario Works Act, 1997*, the *Ontario Disability Support Act, 1997* or the *Day Nurseries Act*, or any government department responsible for social housing programs under the *Housing Services Act, 2011*, or the Housing Services Division housing portfolio operating agreement;
- To the Government of Canada, a department, ministry or agency of it, without further notice to me if the information is necessary for the purpose of administering or enforcing the *Income Tax Act (Canada)* or the *Immigration Act*;
- To any agent working on behalf of the Housing Services Division for the purposes of complying with the *Housing Services Act, 2011*;
- To relevant agencies or next of kin in case of emergency;
- To credit bureaus and other businesses that provide credit or rental history information about me;
- To a third party in connection with the potential or actual sale, reorganization, merger, consolidation or disposition of the business of the Housing Services Division.
