



Financial Statements and Affidavit of Contributions

1. Financial Statements

Under section 88.23 of the amended Municipal Elections Act, 1996 the Clerk must make available a report to the public setting out all Candidates in an election and indicating whether each Candidate complied with section 88.25 (which requires candidates to file Financial Statements in the prescribed form within a specified timeframe).

Pursuant to section 88.29, the Clerk shall also provide a report regarding whether registered third parties has filed financial statements.

Accordingly, the following table sets out each Candidate and Third Party Advertiser and whether or not they have filed their Financial Statements.

2. Candidates for Council

Pursuant to section 88.34 (2), the Clerk shall provide a report identifying each contributor to a Candidate who appears to have contravened any of the contribution limits in section 88.9. The report is to set out any details regarding the contributions that appear to exceed the limits in section 88.9.

I, Manon L. Levesque, City Clerk for The Corporation of the City of Cornwall, do solemnly declare that:

- a. There are no contributors whose total contributions to a Candidate for office on a council who exceeded the limit under section 88.9
- b. There are no contributors whose total contributions to two or more candidates for office on the same Council that have exceeded the limit under section 88.9

3. Registered Third Party Advertisers

Pursuant to section 88.36 (2), the Clerk shall prepare a report identifying each contributor to a registered third party who appears to have contravened any of the contribution limits in section 88.13.

I, Manon L. Levesque, City Clerk for The Corporation of the City of Cornwall, do solemnly declare that:

- a. There are no contributors whose total contributions to a registered third party who exceeded the limit under section 88.13
- b. There are no contributors whose total contributions to two or more registered third party who have exceeded the limit under section 88.1

4. Candidates for Local Boards

Pursuant to section 88.34, the Clerk shall prepare a report identifying each contributor to Candidate for office on a Local Board who appears to have contravened any of the contribution limits under section 88.9

I, Manon L. Levesque, City Clerk for The Corporation of the City of Cornwall, do solemnly declare that:

- a. There are no contributors whose total contributions to a Candidate for office on a local board who exceeded the limit under section 88.9
- b. There are no contributors whose total contributions to two or more Candidates for office on the same local board who have exceeded the limit under section 88.9

I make this solemn declaration conscientiously believing it to be true and knowing that it is of the same force and effect as if made under oath and by virtue of The Canada Evidence Act.
