January 21, 1971.

A Special Meeting of City Council was held this evening with the following members present - His Worship Mayor N. Kaneb, Aldermen L. Gauthier, R. Carrara, R. Brunet, D. Webster, D.A. Fawthrop, F. Guindon, G. Camernn, K. Bough, A. Lebano, J. Pescod and M. Holden.

Adoption of Minutes

Moved by Alderman Gauthier, seconded by Alderman Cameron, that the Council minutes of the meeting held January 11th be adopted as received. Unanimously adopted.

COMMUNICATIONS1. Canadian Martyrs Parish - Monthly Bingo over radio

Moved by Alderman Carrara, seconded by Alderman Holden, that permission be granted to Canadian Martyrs Parish to hold a monthly bingo over radio station CFML and that their application for a license be forwarded to the Province. Unanimously adopted.

Alderman Lebano again brought up the fact that he would like to see the City of Cornwall conduct its own lottery.

Alderman Cameron asked if the City issues licenses for the sale of "Loto" tickets purchased by Cornwall residents. If not, he suggested that the City investigate the possibility of licensing the sale of these tickets or preventing their sale in the City of Cornwall.

Alderman Lebano wanted to make Council aware of the fact that he and Alderman Webster had attended a recent meeting of the Children's Aid Society and had voted against salary increases as submitted. It was a tie vote and the Chairman voted in favour of the increases.

Moved by Alderman Gauthier, seconded by Alderman Cameron, that Council adjourn into Committee of the Whole.


Following a meeting of Committee of the Whole Council reconvened.


Moved by Alderman Cameron, seconded by Alderman Carrara, that the report be adopted as received. Unanimously adopted.
