

CITY COUNCIL NO. 9-73

April 25, 1973.

7:00 p.m.

A Special Meeting of City Council was held this evening with the following members present: His Worship Mayor E. C. Lumley, Aldermen G. Leger, A. LeBlanc, G. Samson, D. Webster, D. Fawthrop, F. Guindon, K. Bough, A. Lebano, J. Pescod and M. Holden.

Excused from Meeting - Moved by Alderman Lebano, seconded by Alderman Samson that Aldermen Clement and Cameron be excused from attendance at this evening's meeting. Carried.

Red Cross Certificate - His Worship Mayor Lumley presented Messrs. S. Hill and F. Roderick, with certificates indicating that they have each contributed 75 bottles of blood to the local Canadian Red Cross Society. On behalf of Council and fellow citizens of the City, the Mayor commended these gentlemen for their humanitarian work.

DELEGATIONS

Recycling Project - Miss Elaine Kennedy asked assistance from Council in obtaining a warehouse where newspapers can be stored until they are sold to be recycled and, in this way, help reduce pollution. Alderman Lebano suggested that a building owned by C.I.L. at Brookdale Avenue and Water Street might be available. Mayor Lumley stated that he would contact C.I.D.L. to see if it might have a building suitable for this purpose.

Adoption of Minutes - Moved by Alderman Pescod, seconded by Alderman Holden that the Council minutes of a meeting held

April 9th be adopted as received. Carried.

Alderman Guindon referred to the noise and dust problem caused by trucks parking on Hebert Street. He was advised that this matter has been referred to the Planning Board to consider the rezoning of the area.

Answering Alderman Lebano, Mr. Boyer advised that he had spoken to Mr. Ken Gosling who is to furnish Alderman Lebano and Mayor Lumley with a sample of a plaque that might be suitable for presentation to Mr. Ron Ward.

NEW BUSINESS

French Week - Mayor Lumley reported that he had a request that the City sponsor a girl in the French Week beauty pageant. Council agreed to this proposal.

Demolition of Building - Mr. Adams advised Alderman LeBlanc that he will inquire as to whether a permit was issued for the demolition of a building on Second Street between Amelia and Adolphus Streets.

Water Supply to Boats - Answering Alderman LeBlanc, Mr. Adams advised that a waterline to fill boats at the dock is being installed at the present time.

McConnell Avenue Overpass - Alderman Samson inquired as to the possibility of requesting from C.N.R., an overpass on McConnell Avenue as complaints have been received that one day the lights were not in operation. Mr. Adams pointed out that until 1970, the City was in negotiations with C.N.R. and the Canadian Transport Commission to construct an overpass. Further action was postponed because of the costs and also the Commission was re-evaluating the government's position to increase the subsidy levels. Further, the City should decide whether they wish an overpass on McConnell Avenue or Boundary Road.

Justice Building - Alderman Bough reported that he will meet with the tenants in the Justice Building and decide whether a formal official opening should be held.

Industrial Committee - Alderman Webster advised that a letter had been received from the United Counties indicating its interest in appointing members with the City to a joint Industrial Committee.

Moved by Alderman Webster, seconded by Alderman Lebano that a joint Industrial Committee be formed to comprise City representatives and members of the United Counties. Carried.

Sydney and Eighth Streets Intersection - Alderman Guindon questioned the authority for erecting stop signs at the intersection of Eighth and Sydney Streets as this arrangement, in his opinion, has caused a traffic congestion and further, there is no by-law to support this change. Alderman Guindon further stated that he had discussed the problem with the Police Department who did not favour stop signs at this intersection. Mr. Adams replied that information he had received was different from that presented by Alderman Guindon and that his department had checked with the Ministry of Transportation and Communications and further, from his discussions with the traffic section of the Police Department, they favoured stop signs at this corner to detour while Pitt Street between Ninth and Eleventh Streets is being reconstructed. The Engineering Department is to again study the detouring of traffic away from Pitt Street.

Justice Building - Alderman Lebano complained that one of our citizens was quite disturbed when he was refused permission to tour the Justice Building. Alderman Lebano pointed out that this did not create good public relations and that ratepayers should be given an opportunity to see how their money is being spent.

Certificate of Merit - Alderman Lebano informed Council that official recognition is given each year to a certain number of people by the Federal Government. He suggested that Dr. I. M. Gourley's name be submitted as he has given outstanding service

over 35 years to the community as a member of the medical profession. He asked that his name be submitted to Honourable L. Lamoureux.

Adjournment - Moved by Alderman Guindon, seconded by Alderman Lebano that Council adjourn into Committee of the Whole.

Following a meeting of Committee of the Whole, Council reconvened.

Committee of the Whole No. 8-73 - Moved by Alderman Holden, seconded by Alderman Lebano that the report be adopted as received. Carried.

Adjournment - Moved by Alderman Guindon, seconded by Alderman Webster that Council adjourn at 11:00 p.m.
