

CITY COUNCIL #19-74

August 19, 1974

A Regular Meeting of City Council was held this evening when the following members were present - His Worship Mayor E. C. Lumley, Aldermen G. Leger, A. Leblanc, G. Samson, A. Clement, D. Webster, D. Fawthrop, F. Guindon, G. Cameron, K. Bough, A. Lebano, J. Pescod, and M. Holden.

D E L E G A T I O N S

Mr. Roland Boileau and others - Re: Transport on Balmoral Ave.

Mr. Albert Parsons voiced the complaints of residents of Balmoral Ave., about the operating procedure of the Laidlaw Transport Company. The Mayor pointed out that the Laidlaw Transport Co. is not breaking any By-law in that in 1970, this land was approved as Manufacturing land and their trucks are permitted to operate here. It was also requested that Laidlaw Transport build their loading dock on the northside of the building rather than the south where it is presently situated. The Mayor noted that there is nothing legal that the City can do to make this company transfer loading docks but they could try to persuade them to follow the people's wishes.

Alderman Lebano pointed out that this situation is very sad as a great deal of money was spent on a park in this area and we are presenting a safety hazard to the children with the transport trucks.

There was a suggestion that Balmoral Ave. should be made a "No Trucking" route but no concrete decision was made on this suggestion.

Fire Chief L. Carriere stated that although the 625 gallon pump will not push as much water as the 1050 gallon pump it will push it as far and would; therefore, be adequate for use in the City of Cornwall. With a good fire hydrant (and there are many, he stated, in Cornwall at this time) the 625 gallon pump could push 840 gallons.

Also the new snorkel ordered will have a 1050 pump on it so the Fire Chief, upon consideration, recommended that the City of Cornwall purchase the 625 gallon pump.

Council also suggested that maybe the City could try for a lower bid with King Seagrave, because of the fact that the King Seagrave Company is delivering the snorkel almost two years late.

The Administrator the the Clerk pointed out that if we do not follow our tendering procedure, then the low bidder may decline from bidding in the future.

Alderman Lebano was against restrictions of any kind, feeling that they were discriminatory against some people. Alderman Leger agreed with this.


