

CITY COUNCIL - #24-77

August 8, 1977

The Regular Meeting of City Council was held this evening with the following members present - His Worship Mayor G. Parisien; Aldermen P. Armstrong, R. Aubry, G. Cameron, G. Guindon, L. Keen, L.G. Lavigne, A. Lebano, A. LeBlanc, B. Lynch, J. Pescod, G. Samson. Ald. Williamson was out of the country.

Adoption of Minutes - Moved by Aldermen Pescod and LeBlanc that the minutes of the Council meeting of July 25th be adopted. Carried.

Moved by Aldermen Lynch and Samson that the minutes of the Committee of Council meeting of July 25th be adopted. An amendment to the motion was made by Aldermen Keen and LeBlanc that the minutes be adopted with the deletion of the paragraph 'Transit Service'; and that this item be dealt with in Committee of Council. The amendment carried. The motion was defeated.

Committee of the Whole - Moved by Aldermen Lebano and Aubry that Council go into Committee of the Whole and that all delegations, resolutions, communications and by-laws be referred to that Committee and that by-laws Nos. 090 to 093 incl., as listed, be given a first reading -

- 090 - respecting const., maintenance & protection of blvds. under reg. plans of subdivisions
  - 091 - auth. signing of Encroachment Agreement with R.&A. Fillion
  - 092 - to establish part of Pitt St. as a mall
  - 093 - auth. signing of Subdivider's Agreement with C. Lawn & K. Bergeron
- Carried

Delegations - Mr. B. Perrault of 31 Fennell Crescent was the spokesman for the residents of this street. He listed several reasons why the residents thought that there was negligence in not providing adequate services to prevent flooding. He indicated that there was a malfunction of the pumping station and that there was no auxilliary pump available; also, had the Fly Creek not been diverted, many of the problems would have been avoided. He suggested that some type of relief fund be set up to assist those in need. He further stated that in the last three or four years, three surveys had been done to measure height from the basement floor to the window in that subdivision. In his opinion, this represented a lack of control where the same thing had been done several times.

Moved by Aldermen Lynch and Lebano that the Director of Public Works prepare a report answering the comments made by Mr. Perrault and that a possible permanent solution also be outlined. Carried

Mr. Albert Lalonde asked that Council adopt in principle the concept of a aquaslide in either Lamoureux Park or Guindon Park. He stated that he would require a water supply; two to three acres of land and be close to Water St unless located elsewhere. This attraction would employ approximately ten persons and would hopefully be ready for operation by June 1, 1978.

Moved by Aldermen Aubry and Lebano that the request be referred to administration for consideration in Guindon Park or any other site that could be suitable for this type of venture. Carried. It was also suggested that the Gray's Creek area be also considered in conjunction with the Raisin Region Conservation Authority.

Resolutions - #53 - Moved by Aldermen Guindon and Pescod that Council agree that Elgie, Walsh & Dhanani be granted an extension of time to Sept. 30, 1977 for development of Hill Island subdivision in part of lot 11, conc. 2 in the City of Cornwall. Carried

Consent Agenda - Moved by Aldermen Aubry and Cameron that the following items, as listed on the Consent Agenda, be approved -

A. Cornwall Rugby Club - to conduct a raffle lottery from Aug. 29-Sept. 3/77

Communications -

1. Emma & Mulberry Streets - Moved by Aldermen Pescod and Lynch that the Judge be advised that City Council is insistent upon the change of Mulberry Lane to Woods Lane. Carried
2. Tax adjustments - Moved by Aldermen Guindon, seconded by Aldermen Samson that tax adjustments be approved in accordance with the list of July 27th of the Tax Collector. Carried
3. Metric speed limits - Moved by Aldermen Aubry and Pescod that Council endorse the resolution of the municipality of Ottawa-Carleton. Carried
4. City owned property near Leitch Drive - Moved by Aldermen LeBlanc and Keen that the debris on City owned land in the Industrial Park be cleared, at an estimated cost of \$2,000.00. Carried
5. Indigent Funeral Rates - Moved by Aldermen Guindon and Lynch that indigent funeral rates be increased to \$500.00 effective August 1, 1977. Alderman Aubry requested a recorded vote. For the motion: Aldermen Armstrong, Pescod, Lebano, Cameron, Guindon, Keen, Lynch, Samson, LeBlanc and Lavigne. Against the motion: Alderman Aubry. Motion carried.
6. Canada Works Program - Moved by Aldermen Lynch and Cameron that the City not participate in the Canada Works Program and that our member of Parliament be so advised. Carried
7. Driveway at 517 Joyce St. - Moved by Aldermen Lynch and Pescod that Mr. H. Martin, 517 Joyce St. be advised that the City is not prepared to reconstruct the driveway to his premises across the municipal boulevard on Joyce St. Carried
8. Iroquois Chemicals Ltd. - Moved by Aldermen Guindon and Samson that the letter of appreciation on action taken by the City to the company's water supply be filed. Carried
9. Tender #41 - Moved by Aldermen Cameron and LeBlanc that the tender be awarded to Fawcett Metal Products Ltd. and United Co-operatives of Ontario in accordance with the report of August 2, 1977. Carried
10. Home Support Program - Moved by Aldermen Lynch and Cameron that the City not take part in the Home Support Program and that the Minister of Social Services be so advised. Carried
11. City Day Care Centres - Moved by Aldermen Guindon and Pescod that the admission fee to the two Day Care Centres be increased to \$10.00 per day, per child. Carried

Committee of the Whole - Moved by Aldermen Cameron and Samson that the Committee of the Whole be adopted. Carried

By-laws - 3rd reading - Moved by Aldermen LeBlanc and Guindon that By-law 092 be dealt with separately from the other by-laws. Carried

Moved by Aldermen Aubry and Lynch that By-laws 090, 091 and 093 be taken as read a third time and finally passed. Carried

Moved by Aldermen Guindon and Lebano that By-law No. 092 be deferred until the O.M.B. Hearing is held re the Regional Shopping Centre. Alderman Guindon requested a recorded vote. For the motion: Aldermen Lebano, Guindon, Keen, Samson, and LeBlanc. Against the motion: Aldermen Armstrong, Pescod, Aubry, Cameron, Lynch and Lavigne. Motion defeated.


Moved by Aldermen Aubry and Lynch that By-law No. 092 be taken as read a third time and finally passed. Carried

New Business - Curfew - Moved by Aldermen Lebano and Guindon that the 10 o'clock curfew for children under 16 years of age be enforced. Carried

Canada Works Program - Moved by Aldermen Aubry and Pescod that administration prepare a report indicating the City's initial cost, and continuing cost if it had participated in the Canada Works Program. Carried

Moses Saunders Dam - Moved by Aldermen Keen and Guindon that the administration inquire into whether regular inspections are made of the Moses Saunders Dam. Carried

Pitt St. mall - Moved by Aldermen LeBlanc and Lavigne that a referendum be placed before the City electors to determine whether or not they would favour a pedestrian mall on Pitt Street and that the referendum be held as soon as possible. Alderman LeBlanc requested a recorded vote. For the motion: Aldermen Guindon, Keen, Samson, LeBlanc and Lavigne. Against the motion: Aldermen Armstrong, Pescod, Lebano, Aubry, Cameron and Lynch. The motion was defeated.
