

CITY COUNCIL - #7-77

February 14, 1977

Moved by Alderman Keen, seconded by Alderman Samson that the minutes of the Council meeting of January 24th be adopted as received. Carried

#### Communications -

1. Environmental Control Committee - Moved by Alderman Guindon, seconded by Alderman Lynch that the minutes be adopted as received. Carried.
2. United Way of Cornwall & District - Moved by Alderman Guindon, seconded by Alderman Cameron that the United Way of Cornwall and District be given a grant in the amount of property taxes at 14 First St. West. Carried
3. Fly Creek Winter Control Program - Moved by Alderman Lynch, seconded by Alderman LeBano that an amount of up to \$10,000. be allocated for clearing ice and snow from Fly Creek on two occasions in 1977.
4. Water Filtration Plant Equipment - Moved by Alderman Guindon, seconded by Alderman Williamson that the report of February 8th of the Chief Administrator be adopted. Carried
5. Ottawa & District Hockey Assoc. - Moved by Alderman Keen, seconded by Alderman LeBlanc that the recommendation of the Chief Administrator, dated February 9th, be adopted. Carried
6. Association LeVillage - Moved by Alderman Cameron, seconded by Alderman LeBano that Council approve the recommendations of the

Association Le Village, as set out in its letter of February 8th, for appointments on the Board of Management of the Montreal Road Business Improvement District. Carried

Moved by Alderman Lebano, seconded by Alderman Guindon that Alderman LeBlanc be appointed to the Board of Management of LeVillage. Carried

Moved by Alderman Guindon, seconded by Alderman Pescod that the petition be returned and a petition under the Local Improvement Act be requested. Carried
8. Recreation Committee - Moved by Alderman Keen, seconded by Alderman LeBlanc that the minutes of the meeting of February 1st be adopted as received. Carried
9. City of Woodstock - Moved by Alderman Lynch, seconded by Alderman Guindon that the resolution re separate union for Fire Dept. Officers be filed. 10. Storm sewer odours - Moved by Alderman Lynch, seconded by Alderman LeBlanc that an amount of approximately \$5,000. be allocated for the hiring of a firm to discern the cause of odours in the area north of the Courtaulds Industrial Complex. Carried
11. Tender #60-76 - Moved by Alderman Lavigne, seconded by Alderman Pescod that Lambert-Hoppen be awarded the tender for the supply of a combination auto and truck spray booth at a price of \$5,346.00. Carried
12. Molson Companies Donations Fund - Moved by Alderman Guindon, seconded by Alderman Cameron that the letter be filed. Carried

Moved by Alderman Lynch, seconded by Alderman Cameron that By-laws 016, 017 and 018 be taken as read a third time and finally passed. Carried


New Business -



Pigeon Control - Moved by Alderman Williamson and Guindon that the present control program for pigeons be continued later than March 31st in the N.I.P. bridge area until the problem has been solved to the satisfaction of the taxpayers in the area. Carried
