

CITY COUNCIL #33-79

November 12, 1979.

The Regular Meeting of Council was held this evening when the following members were present - His Worship Mayor G. Parisien, Aldermen D. Armstrong, R. Aubry, G. Cameron, F. Guindon, L. Keen, R. Lalonde, A. Lebano, A. LeBlanc, B. Lynch, J. Pescod, G. Samson and G. Williamson.

PRESENTATIONS

A Certificate was presented to Mr. W.C. Weir in recognition of his 12 years of service on the Committee of Adjustment.

ADOPTION OF MINUTES

Moved by Aldermen Williamson and Lalonde that the minutes of the October 22nd Council meeting be adopted. Carried.

Moved by Aldermen Lebano and Lynch that the minutes of the October 29th meeting of Council be adopted. Carried.

Moved by Aldermen Keen and Cameron that the minutes of the October 22nd meeting of Committee of Council be adopted. Carried.
Alderman Williamson declared his interest and refrained from voting on the motion.

Moved by Aldermen LeBlanc and Guindon that the minutes of the October 29th meeting of Committee of Council be adopted. Carried.

COMMITTEE OF THE WHOLE

Moved by Aldermen Lebano and Samson that Council go into Committee of the Whole and that all delegations, resolutions, communications and by-laws be referred to that committee and that by-laws 135 to 144 be given first reading -

- By-law 135 - To close up part of Lochiel and Champlain Drive
- 136 - To vary the rates with St. Lawrence Power Company
- 137 - To vary the rates with Cornwall Electric
- 138 - To accept a parcel of land from Harold Brown
- 139 - To dedicate and name a parcel of land as South Branch Road
- 140 - To authorize the carrying on of a Community Programme of Recreation within the meaning of the regulations under the Ministry of Culture and Recreation Act
- 141 - To authorize the signing of Agreement with Elinor Senior
- 142 - To amend the Traffic By-law
- 143 - To sell land in the Industrial Park to Heuga Canada Limited
- 144 - To designate the Capitol Theatre as a building of architectural and historical value or interest

DELEGATIONS

Mr. D. Paquette who resides at 496 Fifth Street West indicated that he was before Council representing the residents of the west end of Cornwall. He described the route he has to take when he is proceeding south on Brookdale. He has been residing on Fifth Street West for 37 years and cannot recall any major accidents or other events that would cause the Traffic Department to close off that section of Fifth Street from Brookdale. In his opinion it just doesn't seem logical to have residents drive approximately $1\frac{1}{2}$ miles in order to get to their homes which are a few hundred feet from Brookdale. City Council received Mr. Paquette's presentation and indicated that his petition would be considered later on in the evening.

- #39 - Moved by Aldermen Williamson and Pescod that by-law 126, 1979 is according to the Official Plan of the City of Cornwall; there is no proposed amendment to the Official Plan contrary to the by-law; and there has been no amendment, by by-law, to the Official Plan which has not been approved which would be contrary to the proposed by-law. 2. Dust & Noise Complaint, Adolphus St. - Moved by Aldermen Lynch and Williamson that Adolphus St. from Tenth to Eleventh be included in the 1980 temporary pavement program for approval at budget time. Carried.

- 3. Paddle Boats, Guindon Park - Moved by Aldermen Williamson and Samson that a public tender be called for a two-year period including 1980 and 1981 for a paddle boat operation, inclusive of the right to sell canned soft drinks and other confections of a similar nature and to collect a fee for the rental of the said paddle boats. Carried.
- 4. Stop on Pitt at Cornwall Square - Moved by Aldermen Guindon and Armstrong that the stop condition on Pitt southbound at Cornwall Square be removed. Carried.
- 5. Bicentennial Committee - Moved by Aldermen Lebano and Armstrong that the minutes of August 10th be received. Carried.
- 6. Bicentennial Committee - Moved by Aldermen Lebano and Keen that the minutes of October 26th be adopted. Carried.
- 7. Recreation Committee - Moved by Aldermen LeBlanc and Lynch that the minutes of October 23rd be adopted. Carried.
- 8. Cornwall Planning Board - Moved by Aldermen Pescod and Guindon that the minutes of October 31st be adopted. Carried.
- 9. AM Radio Station in Cornwall - Moved by Aldermen Pescod and Cameron that the City has no objection to an application by Mr. Gerald Lalonde for a licence to operate an AM Radio Station in Cornwall. Carried.
- 10. No Left Turn from Brookdale to Fifth - Moved by Aldermen Aubry and Lebano that a petition from Dan Paquette and others opposing the the restriction be referred to the Traffic Engineer. Carried.
- 11. AM Radio Station in Cornwall - Moved by Aldermen Lebano and Pescod that the City has no objection to an application by Centrex Broadcasting for a licence to operate an AM Radio Station in Cornwall. Carried.

By-laws - Third Reading - Moved by Aldermen Aubry and Lebano that By-laws 136 to 144 as listed on the agenda for third reading be taken as read a third time and finally passed. Carried.

NEW OR UNFINISHED BUSINESS

Stop Sign, Seventh St. - Moved by Aldermen Armstrong and Aubry that the Traffic Engineer report on the need for a stop sign on Seventh Street, going west, and the former Holiday Inn Road and indicate whether this sign can be removed. Carried.

At this point in the meeting Alderman Aubry asked to be excused from the meeting.



Traffic Sign Brookdale & Thirteenth - Moved by Aldermen Lynch and Guindon that the Traffic Engineer be directed to instal a temporary lettered sign on Brookdale near Thirteenth indicating No Left Turn from Brookdale onto Vincent Massey Drive. Carried.

Cost Saving Innovations - Moved by Aldermen Lynch and LeBlanc that Administration study the report received and prepare for Council a presentation indicating which, if any, of the innovations can be implemented. Carried.


Menard Avenue - Moved by Aldermen Samson and lebano that the Director of Engineering Services be directed to place in the 1980 budget improvements to Menard Avenue, Carried.
