March 26, 1979.

Adoption of Minutes

Moved by Aldermen Lynch and Keen that the minutes of the March 12th Council meeting be adopted. Carried.

Moved by Aldermen Lalonde and Pescod that the minutes of March 12th Committee of Council meeting be adopted. Carried.

Cline House & Capitol Theatre - Dr. R. Burns, Chairman of the Local Architectural Conservation Advisory Committee, recommended that Council designate the Capitol Theatre and the Cline House as historical sites under The Ontario Heritage Act.

Moved by Aldermen Lynch and Cameron that the Cline House, 208 Second Street East, be designated as property of historical and architectural value under the Ontario Heritage Act. Carried.

Committee of the Whole - Moved by Aldermen Pescod and Williamson that the Committee of the Whole be adopted. Carried.


