McConnell Avenue Grade Separation Project - Moved by Aldermen Williamson and Aubry that the City continue with the proposal to construct an overpass at McConnell Avenue/CNR mainline crossing as originally planned and that the City make a formal offer to Kee Mar Ltd. of \$20,000 for a required parcel of land. Carried

By-law No. 134 - Moved by Aldermen Lalonde and Cameron that By-law No. 134 being a by-law to authorize the signing of a Child Services Agreement be read a first, second and third time, passed, signed and sealed. Carried

By-law No. 135 - Moved by Aldermen Pescod and Lebano that By-law No. 135 being a by-law authorizing a power rate increase for Cornwall Electric be read a first, second and third time, passed, signed and sealed. Carried

By-law No. 136 - Moved by Aldermen Pescod and Lebano that By-law No. 136 being a by-law to authorize a power rate increase for St. Lawrence Power Co. be read a first, second and third time, passed, signed and sealed. Carried



