

CITY COUNCIL #15-82

May 10, 1982.

The Regular Meeting of City Council was held this evening when the following were present - His Worship Mayor G. Parisien, Aldermen D. Armstrong, R. Aubry, G. Cameron, F. Guindon, R. Lalonde, A. Lebano, A. LeBlanc, G. Leger, J. Pescod, J. Samis, G. Samson and W. Wise.

PRESENTATIONS

Certificates and pins in recognition of 25 years of service were presented to the following firefighters - Gilles Racine, George Laplante, Henry Cousineau, Clifford Latour, Edwin Stewart and Leon Lemire. Hugh Gravely was not available for the presentation.

ADOPTION OF MINUTES

Moved by Aldermen Lalonde and LeBlanc that the minutes of the April 26th meeting of Council be adopted. Carried

Moved by Aldermen Pescod and Leger that the minutes of the April 26th meeting of Committee of Council be adopted. Carried

Planning Board Report 5-1 and By-law 68 were deleted from the agenda and referred back to the Planning Board and By-laws 69 and 70 were renumbered as 68 and 69.

COMMITTEE OF THE WHOLE

Moved by Aldermen Leger and Lebano that Council go into Committee of the Whole and that all delegations, resolutions, communications and by-laws be referred to that Committee and that By-laws 66 to 69 be given first reading.

- By-law 66 - Amendment No. 47 to the Official Plan (Holding Designation & Policies)
- 67 - To amend the Zoning By-law (Holding Zones)
- 68 - To authorize signing of Agreement with Family Counselling Centre
- 69 - To authorize signing of lease with NC Gas (Parking)

DELEGATIONS

Rezoning on Hebert - Mr. Hubert Lalonde indicated that he represents several residents on Hebert Street who object strongly to the rezoning of property described in By-law No. 67. He stated

that the people in the area are very annoyed at the fact that the City is not enforcing its municipal by-laws. The property in question has caused considerable nuisance as far as noise, pollution and many other aspects and it seems that the City is helpless as far as finding a remedy to this situation. All the residents are interested in for that area is clean and quiet enjoyment and a place to live that is expected in a residential zone. He stated that activities taking place on the property concerned have done everything to defeat the purpose of a residential area. Several members of Council supported Mr. Lalonde's position that by-law enforcement seems to be lacking and that a more concentrated effort should be undertaken by those agencies responsible. It was agreed that further discussion on this matter would be withheld until Communication #10 is discussed.

Ontario Humane Society - Mr. Ron Adams appeared on behalf of the local branch of the Ontario Humane Society and reiterated that the Society had been investigated by the Solicitor General's Office and had been absolved of any wrong doing. He stated that the local branch is very interested in building an animal shelter on property appropriately zoned and that the structure would cost approximately \$85,000. He asked that Council, when reviewing the item in Committee of Council, agree to sell the parcel of land as described in their offer. Council received Mr. Adams presentation and deferred further discussion to Committee of Council.

1. Emergency Telephone Service - Moved by Aldermen Guindon and Cameron that the matter be deferred indefinitely. Carried
2. Champlain Drive Speeding - MOved by Aldermen Guindon and Leger that the Traffic and Parking Division study driver adherence to the speed limit and pedestrian activity on Champlain Drive and report back on the findings later this summer for possible consideration by the Police Commission. Carried

Mr. Lalonde once again addressed Council and reaffirmed their stand that zoning should not be changed and that existing by-laws should be enforced.

Wire Mesh on Culverts - Moved by Aldermen Samis and Wise that the Engineering Department prepare a report estimating cost and other relevant factors of affixing wire mesh over any culverts in the city which are of a sufficient diameter for a child to be pulled through by unusual volumes of water experienced during spring run-off.

Moved by Aldermen Guindon and Lebano that the meeting continue beyond 11 p.m.


Defeated
