

CITY COUNCIL #16-82

May 25, 1982.

The Regular Meeting of City Council was held this evening when the following were present - His Worship Mayor G. Parisien, Aldermen D. Armstrong, R. Aubry, G. Cameron, F. Guindon, R. Lalonde, A. Lebano, A. LeBlanc, G. Leger, J. Pescod, J. Samis, G. Samson and W. Wise.

ADOPTION OF MINUTES

Moved by Aldermen Lalonde and Leger that the minutes of the May 10th meeting of Council be adopted. Carried

Moved by Aldermen Pescod and Cameron that the minutes of the May 10th meeting of Committee of Council be adopted. Carried

COMMITTEE OF THE WHOLE

Moved by Aldermen Cameron and Samson that Council go into Committee of the Whole and that all delegations, resolutions, communications and by-laws be referred to that Committee and that By-laws 70 to 75 be given first reading.

- By-law 70 - To amend By-law 1180/61 (Hours for Market)  
 71 - Respecting use of Pitt St. Pedestrian Mall as Public Market  
 72 - To authorize signing of Agreement with Red Cross Society Homemakers  
 73 - To authorize signing of Agreement with Baldwin House  
 74 - To fix the levy for the 1982 taxes, including school taxes, and to provide for the payment of taxes by instalments June 30th, July 30th & Aug. 31st  
 75 - To authorize signing of Agreement with VON Carried

DELEGATIONS

Cornwall Regional Art Gallery - Mr. George Sanders addressed Council and stated that Cornwall is in need of a Public Art Gallery. Cornwall has no Art Gallery, the closest being in Ottawa. A gallery is needed to display especially the work of local budding artists. The present membership is 100, of whom 19 are from the Arts Development Association. Mr. Sanders stated the Cornwall

Regional Art Gallery will be at 107 Pitt Street as of June 17th and all are welcome to attend. He asked Council to pass a resolution to the effect that the Cornwall Regional Art Gallery, operated by the Cornwall Gallery Society, -s recognized as the public art gallery for the use and benefit of the citizens of Cornwall.

Moved by Aldermen Guindon and LeBlanc that the request be referred to Administration for a report back to Council. Carried

Relocate Bus Stop - Mrs. Martha Ross Preschern addressed Council stating that she lives at 10 Second Street East and she and her tenants have to fight their way out of the door or when the buses are there it is impossible. Persons waiting also litter the area and cause damage. She suggested the stop be moved, possibly to the former Cornwallis Hotel site.

Mr. Adams stated that he, the Transit Manager and the Traffic Engineer will look into the matter.

Conseil de Vie Francaise - Moved by Aldermen Leger and Lalonde that Rule 10 be invoked to allow a spokesman from the Conseil de Vie Francaise to address Council. Carried

Mrs. G. Leger addressed Council to say she was here to make a presentation on behalf of the TV station from Sherbrooke, Quebec, to the Mayor and citizens of Cornwall and that the program can be seen by watching Channel 10 at 7:30 p.m. from Sherbrooke.

RESOLUTIONS

#14 - Moved by Aldermen Pescod and Guindon that in spite of objection received, Council still supports By-law No. 38. Carried

Alderman Cameron declared his interest and refrained from voting on the matter.

#15 - Moved by Aldermen Samson and Armstrong that whereas the Ministry of Community & Social Services has issued a directive to their Income Maintenance Specialist to approve the Municipal Administration Budget for 1982; and whereas the municipality has no objection to the increase of 11% over the actual expenditures approved by the Ministry for 1981; and whereas the municipality objects to the method used in determining the actual caseloads for the workers by only taking into account

the G.W.A. unemployables and employables and eliminating other services, i.e., hostels, transient hostels, etc.;

and whereas the municipality objects to the use of specialized caseworkers, intake workers and supervisory staff in determining the actual caseload per worker;

now therefore be it resolved that O.M.S.S.A. petition the Ministry of Community & Social Services to change the formula presently being used to approve the 1982 Administration Budget, to use only the caseworkers performing the tasks of home investigations and counselling for a caseload figure rather than all other staff such as intake workers, specialized workers and supervisory staff. This method would reflect the actual caseload per worker as opposed to the low caseload now being recorded.

1. Proposed Airport - Moved by Aldermen Pescod and Aubry that Council -
- a) defeat Resolution #16;
  - b) adopt all the recommendations contained in the minutes of the Airport Committee for their meeting of May 19th;
  - c) strongly urge all of the other partners to support the Airport Committee's recommendations; and
  - d) if need be, lend assistance to the other partners in any way possible to realize the development of an area airport to the benefit of the regional community.

A recorded vote in which the Mayor voted along with the rest of Council resulted as follows -

2. Airport Committee - Moved by Aldermen Aubry and Guindon that the minutes of May 19th be adopted. Carried

2A. Proposed Airport - Moved by Aldermen Lebano and LeBlanc that any and all actions or financial expenditures pertaining to the proposed Bonville Airport project be deferred for the following reasons:

- 1) the close recent Council votes and results of these votes are not satisfactory
- 2) considering the adverse economic conditions of our city, our province and our country
- 3) the close proximity of two major airports at Dorval and Ottawa

Be it further resolved that the final decisions of any such Council actions on this proposed airport project be referred to our taxpayers in a referendum ballot at our coming municipal elections.

A recorded vote resulted as follows:

For the Motion: Aldermen Lebano, Samson and LeBlanc. Against the Motion: Aldermen Armstrong, Pescod, Lalonde, Cameron, Guindon, Samis, Wise, Leger and Aubry.

3. Tender #12-82 - Moved by Aldermen Lebano and LeBlanc that the tender for the installation of a combined sewer on Third, Fourth, Aberdeen and Gloucester be awarded to Cornwall Gravel Co. Ltd. at a total bid price of \$106,255.81. Carried

4. Tender #25-82 - Moved by Aldermen Guindon and Leger that the tender for the lease/rental of word processing equipment be awarded to AES Data Limited at an annual and 5-year total lease/rental package of \$6,560.54 and \$32,802.71 respectively. Carried

5. Tender #27-82 - Moved by Aldermen Pescod and Leger that Items 1, 2A (lead free), 3, 4 & 5 of tender for supply of gasolines, diesel fuels and furnace oil be awarded to Texaco Canada Inc. in a total amount of \$436,275.50.  
An amendment was moved by Aldermen Aubry and Cameron that Administration investigate the BP quotation, since there were no conditions quoted, with power to act on the best tender bid. The amendment carried and the motion was defeated. Carried
6. Tender #32-82 - Moved by Aldermen LeBlanc and Lalonde that the tender for the supply and placing of sod be awarded to R. Flaro Cartage Limited at a total price of \$35,005.00. Carried
7. Boathouse Committee - Moved by Aldermen Leger and Guindon that the minutes of May 11th be received. Carried
8. Girl Guides of Canada - Moved by Aldermen Lalonde and Wise that Council not grant financial assistance as requested. Carried
9. Parking Restrictions Sign Replacement - Moved by Aldermen Aubry and Wise that Council adopt the 9 recommendations from the Traffic Engineer in a report dated May 4th. Carried
10. Cities Energy Conference - Moved by Aldermen Lalonde and Wise that Council support 8 resolution attached to CAO's report of May 14th. Carried  
An amendment was moved by Aldermen Lebano and Samson that the resolutions be taken out of the report and sent to Department Heads for comment. Defeated  
The amendment was defeated and the motion carried.

 Moved by Aldermen LeBlanc and Pescod that our application be revised downward in accordance with information provided in report from Commissioner of Development dated May 19th. Carried

13. Economic Development Strategy for Cornwall -  
 Moved by Aldermen Guindon and Leger that the City of Cornwall file an appropriate application with the Canadian Industrial Renewal Board for up to 100% financial assistance for the preparation of a study. Carried

14. Recreation Committee - Moved by Aldermen Lalonde and Lebano that the minutes of May 18th be received. Carried

15. Recreation Committee - Moved by Aldermen Lebano and Samson that the report of May 18th be adopted. Carried

Committee of the Whole - Moved by Aldermen Lebano and Guindon that Committee of the Whole be adopted. Carried

By-laws - Third Reading - Moved by Aldermen Leger and Pescod that By-laws 70 to 75 as listed for third reading be taken as read a third time and finally passed. Carried

Mr. Adams reported on Item #3 stating that CNR will visit and inspect sites shortly.

NEW BUSINESS

Traffic Signs on Service Roads - Moved by Aldermen Samson and LeBlanc that Administration report back to Council on the feasibility of erecting traffic and no parking signs on the service roads between Alice and Guy and Guy and Carleton as traffic moves too fast and with cars parked it is very dangerous. Carried

Boulevard Driveways - Moved by Aldermen Lebano and Pescod that Council again review our policy on boulevard driveways to our local areas of business within our city to eliminate disturbance and frustrations of our city business people and taxpayers and also to save tax dollars as well.

Carried

King George Park - Moved by Aldermen Lebano and LeBlanc that Administration report back on a request to transfer competitive ball to another park and that this park be used for minor ball and other minor sports.

Carried

Fish Hatchery - Moved by Aldermen Lebano and Samson that Council petition the Provincial Govt. to initiate, build and supply our area with a fish hatchery in Guindon Park or some other location which would become a tourist attraction, create jobs for our area and eliminate importing fingerlings from the U.S.

Carried


