

CITY COUNCIL #6-83

February 28, 1983.

The Regular Meeting of City Council was held this evening when the following were present - Alderman J. Samis, Acting Mayor, Aldermen R. Aubry, F. Guindon, T. Lalonde, A. Lebano, A. LeBlanc, G. Leger, B. Lynch, E. Myers, G. Samson and W. Wise. Mayor Parisien was out of the city on business and Alderman R. Lalonde was absent due to illness.

ADOPTION OF MINUTES

Moved by Aldermen Lynch and Lebano that the minutes of the February 14th meeting of City Council be adopted. Carried

Moved by Aldermen LeBlanc and Guindon that the minutes of the February 21st meeting of City Council be adopted. Carried

Moved by Aldermen T. Lalonde and Leger that the minutes of the February 14th meeting of Committee of Council be adopted. Carried

Moved by Aldermen Samson and Myers that the minutes of the February 21st meeting of Committee of Council be adopted. Carried

Mr. Bob Pearson, Chairman of Le Bicentenaire de Cornwall Bicentennial Corporation reviewed every item listed in the Corporation's 1983 budget request. 7. Tender #4-83 - Moved by Aldermen Lebano and Myers that the tender for supply of tires and tire services be awarded as recommended by the Director of Purchasing and the Director of Public Works. Carried
8. Tender #67-82 - Moved by Aldermen Wise and Guindon that the City of Cornwall enter into an agreement with the Toronto Dominion Bank to provide banking services for a period of three years. Defeated

A Notice of Motion submitted by Alderman Wise will appear on the next agenda to reduce the size of Council.

NEW BUSINESS

- Economic Development Study - Moved by Aldermen Lynch and T. Lalonde that Council study with senior Administration, including the Director of Economic Development, the recommendations of the Cornwall Economic Development Study funded by the Canadian Industrial Renewal Board with a view to developing an economic development strategy that will remedy weaknesses, build upon strengths, exploit opportunities and target specific markets. Carried

Fire Department Staffing - Moved by Aldermen Lynch and T. Lalonde that Administration prepare a report on the staffing situation in the Fire Department so that Council can ascertain whether or not the Fire Department has sufficient staff to provide adequate fire protection for our residents.

Montreal Road and Edward - Moved by Aldermen T. Lalonde and B. Lynch that the Traffic Department investigate alternatives to deal with the traffic problem at the corner of Montreal Road and Edward St. The vote was tied and the Acting Mayor voted in favour of the motion.

Sewer Traps - Moved by Aldermen Myers and Guindon that city residents be advised by means of an advertisement placed in the city newspapers that they should maintain water in their sewer traps, or in older homes, have a water seal installed on the drain.

An amendment was moved by Aldermen Aubry and Wise that City residents be advised that they should maintain water in their sewer traps, or in older homes, have a water seal installed on the drain.

Defeated

There was a tie vote on the amendment and the Acting Mayor voted against the amendment. The amendment was defeated and the motion carried.

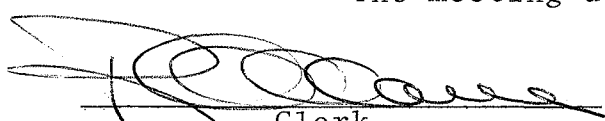

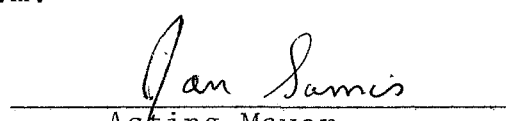
