The Regular Meeting of City Council was held this evening when the following were present - His Worship Mayor G. Parisien, Aldermen R. Aubry, F. Guindon, R. Lalonde, T. Lalonde, A. Lebano, A. LeBlanc, G. Leger, B. Lynch, E. Myers, J. Samis, G. Samson and W. Wise.

ADOPTION OF MINUTES

Moved by Aldermen Guindon and Leger that

Industrial Lands/Real Estate Board - Moved by Aldermen Wise and Guindon that the City enter into an agreement with the Real Estate Board for at least the term of this Council and that during the last 6 months of 1985 a review be carried out and a recommendation forwarded to the new Council to either carry on with such an arrangement or terminate it. Carried
5. Heritage Cornwall - Moved by Aldermen Lynch and Guindon that the minutes of February 9th be received. Carried
6. Floral Map of Canada, Lamoureux Park - Moved by Aldermen R. Lalonde and T. Lalonde that contact be made with the various provinces & territories of Canada seeking financial assistance as well as firming up our submission to E.O.S.A. with a commitment that the Corporation is prepared to meet the component of the construction costs and the annual maintenance costs for a period of 5 years. Defeated  
An amendment was moved by Aldermen Lynch and Samson to defer the matter. Carried  
The amendment carried and the motion was defeated.
7. Tender #67-82 - Moved by Aldermen LeBano and Wise that the City enter into an agreement with the Toronto-Dominion Bank to provide banking services to the Corporation for a period of 3 years. Carried



The Chairman of the Committee of the Whole reported to Council the actions of the Committee including the second reading of the by-law and recommendations for enactment.
