ADOPTION OF MINUTES

Moved by Aldermen R. Lalonde and LeBlanc that the minutes of the July 11th meeting of Council be adopted. Carried

Moved by Aldermen Lynch and Lebano that the minutes of the August 8th meeting of Council be adopted. Carried

DELEGATIONS

Canada Wide Science Fair - Mr. Ken Morgan asked permission to make a 20-minute presentation in order to allow full disclosure of his information.

Moved by Aldermen Guindon and R. Lalonde that the delegation be allowed 20 minutes. Carried

Mr. Ken Morgan explained that his role in the Canada Wide Science Fair is that of publicity and public relations officer and acting chairman. He presented a slide presentation and explained what a science fair is, who participates and who organizes and co-ordinates it. He reminded Council that the CWSF will be held in Cornwall and as such he is hoping for substantial financial commitments from Council. He noted that this year, in Saskatoon, there were 237 entries which represented up to 25,000 children across Canada. Mr. Morgan further noted that 8 years ago the United Counties Science Fair sent 4 participants to the Nationals and this year only one. The reason for this, he pointed out, is that those who supported the programme 8 years ago are donating the same amount as before. It is his hope that more assistance will come in 1984 for a participation in Halifax and also 1985. Mr. Morgan concluded his presentation by stating that he is seeking \$7,500 for convention year 1985.

Moved by Aldermen Lynch and T. Lalonde that this presentation be referred to Administration and that a report be prepared. Carried

Shelter Home - Ms. Sandi McKinnon advised Council that this proposed shelter home is for young women between the ages of 16 and 18 who are in need of treatment and accommodation. This group home would accommodate 8 residents and staff, thus freeing Baldwin House from this need. She stated that funding must come from both the public and private sectors. This project is estimated at \$150,000 and the request to Council is for a \$1,000 cash donation and a \$35,000 loan.

Moved by Aldermen Guindon and Wise that this proposal be referred to Administration for investigation and report. Carried

Treasury Department Reorganization - Moved by Aldermen Lynch and Wise that two permanent staff positions be refilled by Council under the Freeze Policy; one of the positions, namely Supervisor of Cash and Debt, be reduced to an assistant capacity; the position of Financial Analyst be maintained at the current responsibility level; and that the organization be changed to the flow diagram shown on Exhibit 2A under the office of Comptroller. 16. Boals Drain/CNR Crossing - Moved by Aldermen Wise and LeBlanc that the City of Cornwall enter into an agreement with F.E. Johnston Drilling Co. Ltd. in the amount of \$101,000 for the construction of the tunnel component of the Boals Drain/CNR Crossing, the basis of the contract to be the revised plans and specifications for Tender #36-83; and that the City of Cornwall increase Contract #18-83 with Cornwall Gravel Co. Ltd. in the amount of \$28,000 lump sum for temporary works and channel improvements relating to the Boals Drain/CNR Crossing; in addition gabion erosion protection will be paid at the unit rate provided in Contract #18-83. Carried
17. New Transient Marina - Moved by Aldermen Guindon and Lebano that the Transient Marina Committee remain functional for at least one year to provide advice in the early stages of making this facility operationally successful; that visits be made to at least the City of Kingston and possibly also Whitby and Port Dalhousie for the purpose of obtaining advice re: the operation of this facility; and that the City of Cornwall commence immediately a search for a suitable manager. Carried


