A Special Meeting of City Council was held this evening when the following were present - His Worship Mayor G. Parisien, Aldermen F. Guindon, R. Lalonde, T. Lalonde, A. LeBano, A. LeBlanc, G. Leger, B. Lynch, E. Myers, J. Pescod, J. Samis and W. Wise.

The City Clerk called the meeting to order at 6:10 p.m. He advised that on Friday, February 15th he was petitioned by a majority of Council to call a special meeting for the purpose of tabling a notice of motion to reconsider the Gray's Creek Marina.

Also tabled at this meeting was a notice of motion to discuss the Tourism Co-ordinator at the regular meeting of February 25.

After much discussion it was moved by Aldermen R. Lalonde and Pescod that both notices of motion be discussed at the budget meeting of February 20th beginning at 5 p.m.

The motion was amended by Aldermen LeBlanc and T. Lalonde that no time be set for the meeting of February 20th until all members of Council are present at this meeting.

The amendment carried and the motion carried as amended.

Alderman Aubry arrived at the meeting at 6:30 p.m.

It was moved by Aldermen R. Lalonde and Aubry that the two notices of motion be discussed at the meeting of February 20th at 6:30 p.m.

C U R R E N T B U D G E T

During this first meeting for the current budget, City Council reviewed the following departmental budgets: Commissioner of Development, Planning, Economic Development, Civic Complex, Engineering Services, Transit and Police. As a result of these reviews the following actions took place.

Salaries

Moved by Aldermen Wise and Aubry that the salary component of the budget be reduced from 5% to 4%.

Carried

Economic Development

Mr. Moskowitz advised Council that his budget should be revised as follows -

Office Equipment reduced by \$ 1,400

Services & Rents reduced by \$ 4,742

Advertizing reduced by \$28,000

Moved by Aldermen Aubry and Lynch that the Economic Development budget be approved as amended. Carried

Civic Complex


Moved by Aldermen Wise and Guindon that this budget be increased by \$25,000 in order to allow renovations to Salons D1 to D5. Carried


It was further moved by Aldermen Wise and Guindon that the revenue budget be increased by \$10,000 as a result of renovations to be done to Salons D1 to D5. Carried

Transit

It was the consensus of Council that the expense of \$12,000 for the parking lot extension and removal of a hill be deleted which results in a net reduction of \$9,000 after MTC subsidies are applied.
