

CITY COUNCIL NO. 2-86CAPITAL BUDGETJanuary 22, 1986
6:30 p.m.

A Special Meeting of City Council was held this evening when the following were present - His Worship Mayor B. Lynch, Aldermen R. Aubry, D. Carr, B. Gallant, G. Grant, T. Green, F. Guindon, R. Lalonde, T. Lalonde, A. LeBlanc and G. Leger. Alderman Charlebois was absent due to illness. Alderman C. Poirier was absent.

The Chief Administrator reviewed with Council his covering report and recommendations. Council agreed to introduce motions only in the event that changes were desired.

Addendum - \$25,000 to the Police Department

It was moved by Aldermen LeBlanc and R. Lalonde that the request of \$25,000 for the purchase of a police escort vehicle not be included in the Capital Budget.

Arterials

It was moved by Aldermen LeBlanc and Aubry that the monies allocated for Montreal Road from St. Felix Street to Danis Avenue be used for Second Street from Domtar to Riverdale Avenue as Phase I of the total project.

Defeated

It was moved by Aldermen Grant and T. Lalonde that the project Second Street from Domtar to Riverdale Avenue be brought forward to 1987 in the Capital Works Forecasts and that the Director of Engineering Services estimate the cost of the project to be completed in several phases. Carried

Sidewalks

It was moved by Aldermen Leger and LeBlanc that a sidewalk for Montreal Road from the Glen-Stor-Dun Lodge to T.C.T.I. and on Vincent Massey Drive from Brookdale Avenue to Fourteenth Street be deleted from this year's budget.

An amendment was moved by Aldermen Aubry and Green that the sidewalk on Montreal Road from the Glen-Stor-Dun Lodge to T.C.T.I. only be deleted from this year's budget.

The amendment was defeated and the motion was also defeated.

Transit Terminal

It was the consensus of Council that the budget for this item remain in the budget but that the site of the terminal be further reviewed with a report to be placed before Council for final approval.

City Annex Building Renovations

It was moved by Aldermen R. Lalonde and Aubry that this item be referred to Administration for a report which will detail the value of the existing building and the alternatives available for the existing building, other city buildings or leasing of other properties.

Carried

Moved by Aldermen T. Lalonde and Grant that the 1986 Capital Budget be approved and that the Capital Budget Forecast be approved as amended.
