The regular meeting of Council was held this evening when the following members were present: His Worship, Mayor B. Lynch, Aldermen D. Aubry, T. Green, A. Leblanc, D. Carr, G. Leger, C. Poirier, F. Guindon, C. Charlebois, R. Lalonde, B. Gallant, G. Grant and T. Lalonde.

PRESENTATION - Mr. Gerry Brown was presented with a certificate in recognition for his contribution to the Parks and Recreation Hockey School. Mayor Lynch indicated that Mr. Brown had been the originator, Chief Instructor of the hockey school during the last 25 years and that his efforts along with his assistance should be commended.

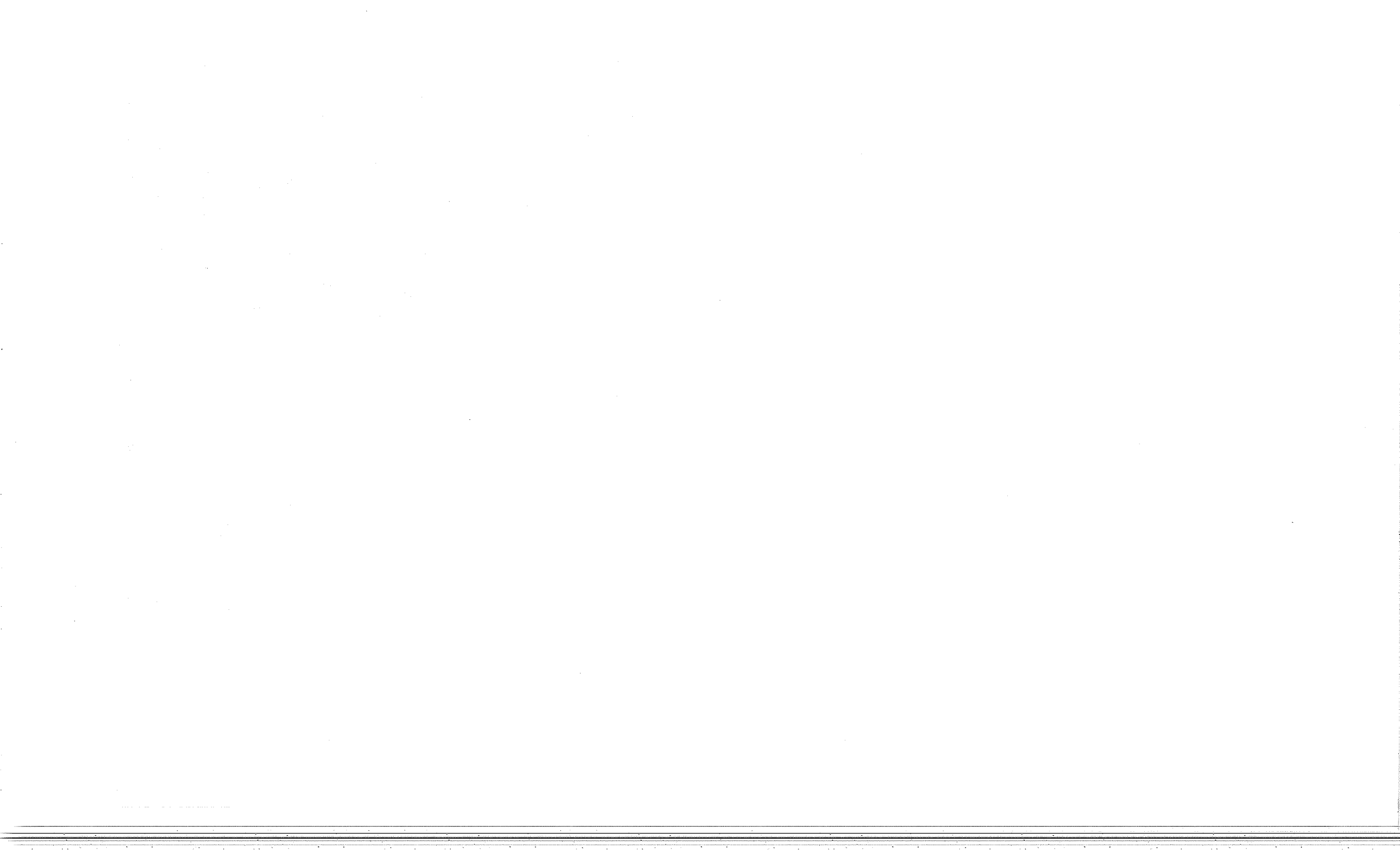

NEW BUSINESS

1. Traffic Lights - Brookdale Ave. and Tollgate Road

Moved by Aldermen T. Lalonde and D. Aubry whereas there has been a significant increase in the number of residents in the immediate area prompting a considerable increase in traffic, therefore, be it resolved that the City Traffic Dept. address the feasibility of installation of traffic lights at the corner of Tollgate Road and Brookdale Ave.

2. Use of Dumpsters at Landfill Site

Moved by Alderman F. Guindon and C. Poirier that the dumpsters at the entrance of Landfill Site where Commissioners are located be put back into full operation as soon as tomorrow morning, October 14th, 1987 and that ^{there be} no charge for car trailers and ½ ton trucks.

3. Update on Figure Skating, hockey and Swimming

Moved by Aldermen Guindon and Leblanc that a verbal report be given at this time regarding figure skating, hockey and swimming. Upon request Mr. O'Reilly explained that all minor hockey monies had been received by the Cornwall Minor Hockey Association, not the City, and that the Association would only be charged for ice time used.
