PRESENTATION -ADOPTION OF MINUTES

Moved by Aldermen T. Lalonde and R. Lalonde that the minutes of the regular council meeting of December 14, 1987 be approved.

Moved by Aldermen Green and Charlebois that the minutes of the Committee of Council dated December 14, 1987 be approved.

COMMITTEE OF THE WHOLE

Moved by Aldermen Charlebois and LeBlanc that Council go into Committee of the Whole and that all delegations, resolutions, communications and by-laws be referred to that Committee and that by-laws no 001 to 007 be given first reading.

- By-Law 001 A by-law to authorize entering into an agreement with the Ministry of the Environment to terminate a previous agreement for the acquisition of Provincially-owned sewage works and the assumption of long-term commitment therefor.
- 002 To authorize entering into an agreement with the Ministry of the Environment with respect to the operation of the sewage works system.
- 003 A by-law directing and enacting the manner in which the interim levy shall be collected

Council request that the Provincial government withdraw this proposed legislation.
