PRESENTATIONS

1. Drinking & Driving Committee of the Mayor's Task Force

Mrs. Sharon Villeneuve representing the Mayor's Task Force on Drinking and Driving explained to Council the purpose behind the Logo Contest.

Students from General Vanier High School were invited to create a Logo in representation to what they believed would be a winning logo on Drinking and Driving. Two selections were made. One student, Jennifer Crain won for the billboard competition. Her poster depicted a car smashing into a beer can entitled "A crashing experience". Shannon Goodwin won for the flyer and poster competition depicting a pair of hands holding a beer can and keys bound together by hand cuffs entitled "Bound by your actions".

Both students were congratulated and separately presented with a \$50.00 cheque. Billboards, flyers and posters will be distributed this summer throughout the community in hopes of educating the Community on the dangers of drinking and driving.

DELEGATIONS

1. Lochiel Street

Mrs. Sheila Duncan restated her concerns of the traffic volume and the problems faced by residents of Lochiel Street. Following Mr. Orchin's traffic count it was noted that 6950 cars use Lochiel Street on a daily basis. Mrs. Duncan presented a petition collected from the residents of Lochiel/Stormont/Chelsea/Patricia/Kenyon and Glengarry, during the summer of 1991. There are 240 signatures who share the same concern.

In conclusion to Mrs. Duncan's delegation, it was moved by Aldermen Aime LeBlanc and Ray Lalonde that the Chief Administrative Officer and the Traffic Engineer schedule a meeting with all residents involved in the petitions submitted and that this meeting be scheduled within the next ten (10) day period.

2. Eastern Ontario Music Festival

Judith Pentinga represented the Eastern Ontario Music Festival and informed Council of the purpose of this organization. There will be concerts held in Cornwall on July 7th and July 10th at the Knox's St. Paul's United Church.

The group of musicians is composed of national and international artists. By coming to Cornwall they plan on combining forces with local musicians for those concerts given in our area. This group has made professional recordings and been broadcast on CBC.

Mrs. Pentinga invited all interested Cornwall residents to be a part of this inaugural series and to share the excitement of this new venture for the City of Cornwall.

In conclusion, it was moved by Aldermen Ray Lalonde and Aime LeBlanc that Council receive this delegation.

COMMUNICATIONS

1. Reneal Street

It was moved by Aldermen Dick Aubry and Norm Lalonde:

1. That the following turning movements be prohibited:

- a) Sydney Street - northbound - through.
- b) Thirteenth Street - eastbound - left turn.
- c) Reneal Street - southbound - left turn.

2. That temporary turn restriction signs and construction markers be erected for a trial period commencing summer 1992 during which time observations and counts can be undertaken to determine if the measures have the desired effect.

3. That should the trial prove successful, permanent reconstruction of the intersection of Reneal Street at Thirteenth Street/Sydney Street/Lemay Street be considered by Council during the 1993 Capital Budget deliberations.

CARRIED

2. Proposed Parking Restrictions

It was moved by Aldermen Brian Sylvester and Chuck Charlebois:

1. That parking on Amelia Street from Third Street to Fourth Street be prohibited 8:00 a.m. to 6:00 p.m. Monday through Friday.

3. a) That parking be prohibited at all times on the south side of Ridgewood Drive from McConnell Avenue to Marlborough Street.

b) That parking be restricted to a 2 hour limit 8:00 a.m. to 6:00 p.m. Monday to Friday on the north side of Ridgewood Drive from McConnell Avenue to Marlborough Street.

c) That parking be prohibited on the east side of Valecrest Drive from Ridgewood Drive to Valecrest Drive (south).

5. That parking on the north side of Eighth Street be prohibited 8:00 a.m. to 6:00 p.m. Monday through Friday in front of the St. John Bosco School; and

4. That recommendation number 4 be deleted from the report.

CARRIED

It was then moved by Aldermen Aime LeBlanc and Ray Lalonde that recommendation #2 be deferred to the regular meeting of July 13th, 1992 in order that the Traffic Engineer has an opportunity to negotiate further with the Cornwall Curling Club.

CARRIED

3. Lochiel Street Area

As per the delegation, this item has been deferred to the regular meeting of July 13, 1992.

4. Second Street West

It was moved by Aldermen Aime LeBlanc and Chuck Charlebois that parking be prohibited on both sides of Frontenac Street, (Second Street to King Street); King Street (Frontenac Street to Young Street); and Young Street (King Street to Second Street) for the duration of the detour required for reconstruction of Second Street West.

CARRIED

5. Skateboards

It was moved by Aldermen Dean Hollingsworth and Terri Lalonde that each item be deliberated and voted on separately.

CARRIED

It was moved by Aldermen Dean Hollingsworth and Dick Aubry that the use of skateboards on all sidewalks and roadways in the Downtown and Le Village areas be prohibited.

CARRIED

It was moved by Aldermen Dean Hollingsworth and Norm Lalonde that the use of skateboards on all major roadways be prohibited by schedule as required.

It was moved by Aldermen Chuck Charlebois and Norm Lalonde that the use of skateboards on City property and parks be prohibited by schedule, as required.

6. Tender 4-92-Reconstruction of Leonard Avenue (Robertson to Shirley Avenue)

It was moved by Aldermen Ray Lalonde and Aime LeBlanc that this tender be awarded to Rose Mechanical Ltd. at a total bid price of \$658,054.28 including taxes, being the low bidder meeting the tender specifications.

7. Tender 23-92-Manhole Frames and covers, catch water basin and frames.




