PRESENTATIONS

1. Health Escapade - Active Living '93

Lee-Ann Lalonde, Coordinator of the 1993 Acting Living Festival, introduced Bow and Bell as the Health Escapade Mascots and proceeded to identify the purpose of their celebrations. Lee-Ann invited the citizens of the Stormont, Dundas, and Glengarry, and the citizens of the Prescott & Russell communities to participate in the many scheduled activities to be held on for May 29, 1993.

The purpose of these celebrations are to promote daily physical activities and healthy lifestyles.

COMMUNICATIONS

1. VISITORS' INFORMATION CENTER

It was moved by Aldermen Chuck Charlebois and Norm Lalonde that Council approve the Chamber of Commerce's request to install a gazebo in Lamoureux Park at the south east corner of the parking lot, situated between York and Augustus Streets, to be utilized as a Visitors' Information Center. It is our recommendation that this be done on a trial basis for a period of one (1) year from May to September, 1993.

2. **TENDER #32-1993** - Grooming and maintaining ball fields.

It was moved by Aldermen Aimé LeBlanc and Terri Lalonde that this tender be awarded to Malyon Excavation at a total bid price of \$24,802.60 including taxes, and being the low bidder meeting the tender specifications.

3. **TENDER #42-1993** - Supply of Topsoil

Flaro Cartage Limited, being the next low bidder meeting the tender specifications at a per cubic meter price of \$15.25 including taxes, and not to exceed the budget figure of \$90,000.00.


