2. P.A.C. 1-3
S.D. & G. Roman Catholic School Board

Mayor Ron Martelle declared a conflict of interest being his wife is an employee of the School Board, and refrained from discussing or voting on the issue. Mayor Martelle invited Alderman Aimé LeBlanc to assume the Chair, and left the room.

It was moved by Aldermen Norm Lalonde and Chuck Charlebois that the subject property, being 835 Campbell Street, be rezoned from Service Industrial (M.S.), to Service Industrial (M.S.) with a site specific exception to allow general administration school board offices, totalling no greater than 30% of the total floor space of the building.




