**NEW BUSINESS**

**Hot-Air Balloon Festival**

Moved by Alderman Susan Carter and Alderman Denis Carr that:

**WHEREAS** Cornwall City Council passed Resolution #05-95, on Monday February 27, 1995 "supporting and recognizing the Cornwall Lift-Off Annual Hot Air Balloon Festival as a community Festival"; and

**WHEREAS** The Board of Directors of Cornwall Lift-Off '96 are preparing a proposal to host the 1996 Eastern Canadian Ballooning Championships in the City of Cornwall, August 7th to 11th, 1996; and

**WHEREAS** THE Council of the City of Cornwall is committed to stimulating tourism within the Cornwall Area.

**THEREFORE** BE IT RESOLVED that the Council of the Corporation of the City of Cornwall lend it support to the bid proposal of Cornwall lift-off in its attempts to secure the 1996 Eastern Canadian Ballooning Championships.

**PRESENTATION**

*Mr. Ed Kubiczek - CLAS*

Mr. Ed Kubiczek was invited to address Council this evening following a request at the last regular council of January 22nd, 1996. Mr. Kubiczek elaborated a proposal on a voluntary investment plan that would improve services, identify cost savings, while averting staff reductions.

In summary, Mr. Kubiczek indicated that the City could become a self sufficient economy growing less and less dependent on outside investments. Employees could receive a high rate of return to their investment while the city would have available funds for continued investments and higher returns while increasing services, improvements, jobs and most of all, holding the line on taxes while allowing the municipality to continue growth.

Council members took the opportunity to question Mr. Kubiczek on his proposal after which it was

- and in addition, that Council honour the Social Contract Agreement signed with Management/Non-Union.

- **WHEREAS** both Council and Administration have worked together to lessen the financial impact of the Provincial Government's Economic program on the taxpayers of our community; and

**WHEREAS** there is a need to finalize the budget now; and

**WHEREAS** any failure to meet the objectives of the budget plan would come from further cuts to the Operations Budget, identified by Administration and approved by Council;

**BE IT RESOLVED** that Council approve a 2% (\$500,000) general tax increase and that Council, Administration, Unions and Associations work together to eliminate this increase by finding further savings from budget by year-end; and

**BE IT FURTHER RESOLVED** that Administration report to Council on a regular monthly basis their actions in this regard.

⇒ **It** was then moved by Alderman Chris Savard and Alderman Chuck Charlebois that Council vote on items 2, 3, 4 and incremental raises identified through the social contract agreement in Mr. Allaire's report, separately.

- 1) immediately stop all actions related to the privatization of Parks & Recreation department.
- 2) advise RSI that the City is not interested in pursuing their proposal at this stage.

## **DISCLOSURE OF INTEREST**

- Alderman Chris Savard declared a pecuniary interest

*In November of 1995, the Cornwall Chamber of Commerce, his employer, made a presentation dealing with a number of Tourism related initiatives that they were prepared to undertake. This new business item pertained to this presentation.*

**Having declared a pecuniary interest, Alderman Chris Savard left the room and did not take part in any discussion or vote on this matter.**

### **Cornwall and Seaway Valley Tourism**

⇒ Moved by Alderman Dick Aubry and Alderman Brian Sylvester that:

**WHEREAS**, Council in Dec. 1992 adopted unanimously the report by it's sub-committee to form a joint unified combined Tourism/Convention body that would operate at arm's length from Council under a board comprised mainly of Industry people; and

**WHEREAS**, the Cornwall & Region Visitor & Convention Bureau was formed in Jan. 1993; and

**WHEREAS** the City's cost for this activity has decreased from \$271,296 in 1991 as a city operation to \$225,000 then to \$202,500 and now to \$185,000; and

**WHEREAS**, the C.R.V. & C.B. & Seaway Valley Tourism merged their operations in Nov. 1995; and

**WHEREAS** the Cornwall Chamber of Commerce provides a valuable service to the area through its information kiosk;

**NOW THEREFORE**, be it resolved, that notwithstanding the Chamber of Commerce's valuable contribution to Tourism, this Council:

a) *re-affirms its commitment to a single unified combined Tourist/Convention operation, namely the recently emerged Cornwall and Seaway Valley Tourism Group; and*

b) *allocates the total of \$185,000.00 budget support for 1996 to Cornwall and Seaway Valley Tourism; and*

c) *that the Cornwall and Seaway Valley Tourism continue to work towards reducing the City's contribution.*

⇒ It was then moved by Alderman Susan Carter and Alderman Denis Carr that the main motion be amended to identify \$160,000.00 to the Cornwall and Seaway Valley Tourism and that \$25,000 be relayed to the Cornwall Chamber of Commerce specifically for tourism development activities in the City of Cornwall.

⇒ It was then moved by Alderman Dick Aubry and Alderman Brian Lynch that an appeal be placed before Council as a whole to indicate that the amendment is out of order.

Tie Vote resulted in the **Motion Defeated** for want of a majority.

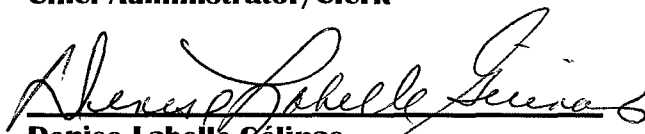
**NOTICE OF MOTION**
