## **COMMUNICATION**

#### **1. TENDER #97-T05, SUPPLY OF BREAD PRODUCTS FOR THE GLEN-STOR-DUN LODGE**

It was moved by Aldermen Brian Lynch and Denis Carr that this tender be awarded to Weston Bakeries, Ottawa, for a two year (2) period at the total bid price of \$11,752.34 being the lowest bid meeting the tender specifications.

#### **2. TENDER #97-T06, SUPPLY AND DELIVERY OF DAIRY PRODUCTS, GLEN-STOR-DUN LODGE**

7. **PETITION - GLENGARRY BOULEVARD CROSSWALK SIGNALS**

It was moved by Aldermen Brian Sylvester and Chris Savard that the report from the Traffic Engineer, under date of February 27, 1997, recommending that pedestrian activated traffic signals in front of 625 and 645 Glengarry Boulevard not be considered at this location be approved.

**8. MUNICIPAL ELECTIONS**

It was moved by Aldermen Denis Carr and Susan Carter that the report from the Deputy Clerk under date of February 25, 1997, be approved, with the following recommendations:

•That Council enact a by-law to permit the use of French in addition to the use of English in notices, forms and information provided or utilized in the conduct of municipal elections.

•That Council enact a by-law to authorize the use of vote counting equipment commencing with the 1997 municipal elections.

•That Council enact a by-law to provide for the conduct of the advance vote in the following manner:

a) a special advance vote period be conducted and available to all City of Cornwall qualified electors for a period of three consecutive days beginning 18 days prior to voting day between the hours of 12 noon and 9 p.m. on Thursday and Friday and 10 a.m. to 5 p.m. Saturday; and

b) a general advance vote days held within the various locations in the City of Cornwall conducted on the Saturday, nine days prior to voting day, between the hours of 10 a.m. to 5 p.m. Saturday.

•That Council enact a by-law:

a) to enable, when applicable, reduced opening hours for those voting places described in subsection 45(7) of the Municipal Elections Act, 1996;

b) to delegate the authority to the Clerk, pursuant to Section 102.1 of the Municipal Act, as amended, to apply reduced opening hours where:

i) the opportunity to vote has been provided to each elector residing within the premise;

ii) the Deputy Returning Officer has verified with the administrators of the dwelling described in subsection 45(7) that no other qualified electors reside within the premise; and

iii) Deputy Returning Officer has confirmed with the Election Office that the requirements prescribed under paragraphs (i) and (ii) have been met.

**WHEREAS** the use of the internet continues to grow at an unprecedented pace;


**AND WHEREAS** Cornwall Economic Development has an informative web site on the internet for economic and business development purposes;
