DELEGATIONS

#1. Rita Street Residents, Marc Bissonnette

Mr. Marc Bissonnette spoke to Council on behalf of residents of Rita Street addressing a number of concerns regarding the condition of the street. Mr. Bissonnette concluded his presentation by requesting action on the following items:

- a) Reattachment of all water run offs to new storm sewer.
- b) Refill all the existing "unwanted" ditches.
- c) Remove all the unwarranted and unwanted pipes at the north end of the street.
- d) Repair all the cracked or broken curbs at the south end.
- e) Repave the street and cup up driveways on west side and on all of the north end.
- f) Resod each cut off or affected lawns.
- g) Review the tees and lights situation on east side.
- h) Replant some new trees on west side where they were cut out.
- i) Reconstruct the end or northern edge of the street, if possible.

It was moved by Aldermen Brian Sylvester and Naresh Bhargava that Council refer this matter to Administration for review and investigation.

#2. Emile Martin - Licensing Issues / Enforcement

Mr. Emile Martin addressed Council this evening to bring forth some concerns he has in regards to the licensing of hot-dog carts and their subsequent enforcement. Mr. Emile proceeded to give a brief history of his experience with some of the festivals this summer and his inability to either secure a location or secure a prime location due to the set up of un-licensed hot-dog carts. Mr. Emile is requesting better enforcement of this type of vendor in order to ensure an equal playing field for all hot-dog cart owners. He also requested that Administration review the classification of hot-dog carts in order to distinguish them as separate entities from Chip Trucks, which require re-location every thirty (30) minutes.

It was moved by Aldermen Angelo Lebano and Brian Lynch that Council refer this matter to Administration for review and investigation.

REPORTS FROM AD HOC COMMITTEES OF COUNCIL

NOTICES OF MOTION: Submitted by Alderman Brian Lynch:

WHEREAS the Association of Municipalities of Ontario as its recent annual meeting passed a resolution asking Ontario municipalities to put the following question on the ballot at the time of November 10th municipal election — “Do you agree that the costs of welfare, social services, and social housing should be downloaded by the province onto the municipal property taxpayer?”; and

WHEREAS programs which redistribute income such as welfare, social assistance, child care, and social housing should be funded by the province from the income tax not by the municipalities through property taxes which are regressive; and

WHEREAS the costs of downloading of social housing and other social services onto the municipalities are enormous and will result in higher municipal property taxes and/or reduced services.

THEREFORE BE IT RESOLVED THAT Cornwall City Council approve the following question to be put on the ballot at the time of the November 10th, 1997 municipal election — “Do you agree that the costs of welfare, social services, and social housing should be downloaded by the province onto the municipal property taxpayer? Yes or No?”.

NEW BUSINESS

1. Withdrawal of Bill 136

It was moved by Aldermen Brian Lynch and Angelo Lebano that:

WHEREAS the Association of Municipalities of Ontario at its recent annual meeting passed a resolution asking the provincial government to withdraw Bill 136; and

WHEREAS Bill 136 takes away the right to strike by public sector unions during first contract negotiations and removes fair, independent arbitration for those public sector workers deemed essential who cannot strike; and

WHEREAS Bill 136 removes free collective bargaining for public sector unions involved in the amalgamation of municipalities, hospitals, and school boards and imposes contracts; and

WHEREAS Bill 136 will create unrest and confrontation between labor and management.

NOW THEREFORE BE IT RESOLVED THAT Cornwall City Council ask the provincial government to withdraw Bill 136 and give the Ontario Labor Relations Board additional powers to handle amalgamations.

NOW THEREFORE BE IT RESOLVED THAT the Traffic Engineer review the present system and prepare a report for Council detailing his findings and any modifications or changes he would propose.

It was moved by Aldermen Dean Hollingsworth and Susan Carter that:

WHEREAS the City of Cornwall is committed to recreation for all residents; and


WHEREAS skateboarding is a legitimate recreation activity; and


WHEREAS skateboarding is prohibited in all City parks.
