The Cornwall Public Library has received a generous donation of equipment in the amount of \$64,000 from the Bill Gates Foundation to create an Internet Training Centre within the Cornwall Public Library. The Library in partnership with Smart City Cornwall, hopes to develop an empty space in the Library's basement to house both the Library's Gates Training Centre and Smart City Cornwall's Domino server.

An architectural rendering for the proposed site is now being prepared by the Rosemount Design Group and was included as part of this evening's presentation.

The Main purpose / objective involves the enhancement of a high profile not-for-profit installation in the City of Cornwall's main business area. The infrastructure development initiative will bring together the efforts and resources of a number of partners from the public, private, not-for-profit and services sectors. Working to a common objective, they would help to raise awareness about e-commerce opportunities by providing a public site to help Cornwall citizens meet the challenges of the new economy.

Mr. McCoubrey stood before City Council this evening and presented them with a petition signed by 225 citizens of Cornwall requesting the construction of a sidewalk for pedestrian traffic along Riverdale Avenue from Second Street extending to the existing sidewalk on Riverdale Avenue at the proposed Ninth Street Extension. Mr. McCoubrey continued to brief Council on its Official Plan submitted in April 1992 which plan recognizes the need for pedestrian facilities.

He continued to clarify that the identified reports, support the need for a sidewalk along Riverdale Avenue and that the citizens who have signed the petition unequivocally support the need for a sidewalk along this roadway. The Riverdale area has a large park and two elementary schools and that the children need a sidewalk to safely and separately access

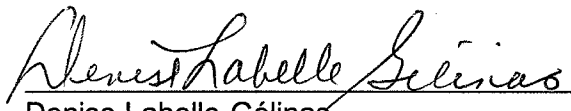
