Dr. Robert Bourdeau spoke on behalf of the Eastern Ontario Health Unit and presented facts and figures to Council on the mortality rate of males and females within the City of Cornwall and S.D. & G United Counties on the effects of smoking and second hand smoke. He continued the presentation by showing various rates standardized to the population of our area on smoking related diseases, age-standardized incidence rates for selected cancer sites for both males, and females including the leading causes of death in infants of one year of age or more.

At the conclusion of the delegation, Dr. Bourdeau requested that City Council form a Committee of Council or a Community Task Force to study the present report; and that City Council enact a 100% smoke-free policy prohibiting smoking in public places with no allowances for designated smoking rooms.

Mr. Marc Lefebvre, owner of Freddy's Roadhouse and representative on behalf of a group of city business owners and service club operators, appeared before Council this evening to speak against a proposed city by-law which they believe would cause serious damage and perhaps lead to the extinction of entertainment industry in Cornwall.

Mr. Lefebvre presented arguments that indicated the population base of the city barely large enough to support the already existing establishments; secondly that many smaller restaurants and coffee shops have been able to remain open because major chains such as Tim Horton have banned smoking in their establishments; thirdly that their smoking customers will perhaps gravitate to bars outside of city limits.

In conclusion, Mr. Lefebvre's presented Council with a petition signed by 4,200 bar patrons and workers against the No-Smoking By-law in municipal bars.

**H. P.A.C. REPORT NO. 3-1, APRIL 17, 2001**

Review of an application for a Zoning Bylaw Amendment from Highway Commercial (C.H.) Zone to Highway Commercial (C.H.) Zone with a site specific exception to permit a (commercial) parking lot without constructing a commercial garage on lands legally described as Part of Lot 7, Concession 2, more specifically Part 1 of Plan 52R-587, City of Cornwall. The site is situated on the west side of McConnell Avenue south of Highway 401 and is referred to as the Villeneuve Trucking operation. (P.A.C. File #295)

1. That the subject lands, described legally as Part of East Half of Lot 7 Concession 2, and Municipally known as 1710 McConnell Avenue, City of Cornwall, be rezoned from Highway Commercial (CH) to Highway Commercial (CH) with a site specific exception to exempt the applicant from constructing a commercial garage;
2. That the property owner of the site, as defined by this particular rezoning, make an effort to complete the Site Plan Process especially to address the issues which will be detailed through the amendment to the existing Site Plan, such as lighting, paving, buffering and drainage; and

3. That third reading of the Bylaw be withheld until such time as a complete application to amend the Site Plan Agreement is received from the developer concerning the necessary improvements through the Site Plan Process.

**I. P.A.C. REPORT NO. 3-2, APRIL 17, 2001**

Review of an application for a Zoning Bylaw Amendment from Residential 20 (RES 20) zone to Commercial 51 (COM 51) zone to permit the establishment of a commercial parking lot for the Paradise Tanning operation on lands legally described as Part of Lot 9, Concession 2, City of Cornwall and immediately east of 1515 Pitt Street. The site is situated on the west side of Reneal Street and south of Birmingham and Kensington Streets. (P.A.C. File #296)

1. That the subject lands, described legally as Part of West Half of Lot 9 Concession 2, and municipally known as the land behind the Paradise Fitness Centre at 1515 Pitt Street, City of Cornwall, be rezoned from Residential 20 (RES 20) zone to Commercial 51 (COM 51 zone) with an exception to prohibit any residential development;
2. That the entire site, as defined by this particular rezoning, be subject to the Site Plan Approval Process; and that an appropriate residential buffer and landscape strip be created along Reneal Street to protect the residential character of the area.
3. That the City be granted a one foot reserve around the limits of the property to ensure no new access are granted.
4. That no excavation take place in proximity to Bore Hole MW-00-3 as identified in the Environmental Comments of this report. Should excavation be proposed near or on the identified area subsequent approvals will be conditional on further testing and applicable remediation taking place.

**J. P.A.C. REPORT NO. 3-3, FEBRUARY 19, 2001**

Review of a City-initiated (Planning Department) application for a Zoning By-law Amendment to propose revisions or a replacement zone to the existing Commercial 41 (COM 41) zone of the City of Cornwall Comprehensive Zoning By-law No. 751, 1969 as amended. The initiative affects a limited number of properties within the Municipality, and are intended to allow a more practical and flexible on-site zoning. (P.A.C. File #297).

1. That P.A.C. endorse and support the contents of this report;
2. That Planning Staff proceed to Step 4 (Section I) with a final report, identifying specific recommendations to replace the Com 41 zoning, and second public meeting; and

Since that time the Municipality has been delegated subdivision approval by the Province and is responsible for reviewing new and re-submitted applications such as this.

The property is described as Block "O" and Part of Block "P", Registered Plan No. 322, located south of Lochiel Street and proposes 15 single family Residential lots. (Subdivision File # 235, 04-T-20011).


