PRESENTATION

1. Financial Statement 2001

Mr. Ross Markell, Auditor and Mr. David Dick, Manager, Financial Services and Mrs. Anita Roach, Chief Accountant presented the 2001 Municipal Financial Statement for Council review.

Highlights of the 2001 Financial Statement, as presented by the Manager of Financial Services and Mr. Ross Markell, Auditor, indicated that the consolidated statement of the financial position for The Corporation reflects the City's positive cash position largely due as a result of the level of fund balances at year end, indicated with a generous surplus of \$1,273,556.00. These surpluses were identified within the General Operating Budget in the amount of \$840,372.00; Waterworks Budget in the amount of \$325,105.00 and Sewer Budget in the amount of \$108,079.00.

It was indicated that the City's debt retirement had been reduced to \$19,753,000 in 2001 in comparison to \$30,853,000 in 1998 when the debt retirement portfolio was established. Mr. Dick reports that this is indeed the municipality's first year in which they are required to report its liability for landfill closure and post closure costs. The Corporation's liability of \$1,183,500 represents the estimate of future closure costs accrued as the landfill site capacity is used. The remaining useful life of the landfill site is estimated to be 25 years. Additionally, Taxes Receivable as a percentage of the total levy has remained close to last year's level at 6.9%. Reserve Funds have been summarized as at December 31, 2001 as having a balance of \$29,288.573 in the Progress Fund and interest earned during 2001 was \$1,645,226.00. As of June 30, 2002, interest earned on the Progress Fund amounted to \$4,915,774 completing the commitment to the aquatic centre project resulting in funds now being available for other "quality of life" items.

Budget variances were summarized through the Corporation's revenues in taxation and payments-in-lieu and government grants. Additionally expenditures within the current operations not previously predicted were identified within the general government services; protection to persons and property; transportation services; environmental services; social and family services; social housing; recreation services and planning and economic development.
