## **PRESENTATION**

### **AFMO - Association française des municipalités de l'Ontario**

Messrs. Gaston Patenaude, Mayor of Russell, Martial Levac, President / Warden of Prescott Russell and Réjean Nadeau, General Director of AFMO made a presentation before the Council this evening to better explain what the Francophone Association of Municipalities of Ontario (AFMO) is all about and what the purpose of their creation is.

They have been in existence for the past 14 years and are the only francophone umbrella sector in Ontario. They do not duplicate the work of AMO yet work in partnership with them. The Association promotes the governance and delivery of french services to all french speaking peoples in Ontario. Mr. Nadeau, who was the general speaker, indicated that the City of Cornwall have a demographic population of 33% french speaking citizens. The City is now one of 38 other municipalities in Ontario who participate with AFMO. Twenty three (23) of the 38 municipalities are located in northern Ontario and represent 90% of all francophones within Ontario.

At present, Mr. Nadeau indicated that their Association was negotiating a tri-partite agreement with all levels of government and which agreement would provide better management and delivery tools for french speaking citizens within all municipalities across Ontario.

Mr. Nadeau also spoke to the upcoming September 2004 Conference and that the Association would like to see the City of Cornwall host the conference. A Memorandum of Understanding Agreement, stipulating the roles, responsibilities and accountabilities of the Association and City of Cornwall's role in hosting the Conference was provided to the council for review.

***In conclusion to the presentation, it was Moved by Councillors Claude Poirier and Susan Carter that the Conference Request be forwarded to Administration for review and report.***

## 3. HEALTH UNIT - SMOKING ISSUE

Moved by Councillors Claude Poirier and André Rivette

**WHEREAS** on June 3, 2002 and pursuant to the *Health Protection and Promotion Act*, the Medical Officer of Health for the Northwestern health unit sent a notice of health hazard advising all businesses that second hand tobacco smoke in indoor spaces is a health hazard, as a result he is requiring that all workplaces in the Kenora and Rainy River districts that are not currently 100% smoke free become 100% smoke-free in 2002; and

**WHEREAS** the implementation of a similar notice by the Eastern Ontario Health Unit in the entire region governed by the unit, would in affect eliminate this health hazard for all employees and patrons; and

**WHEREAS** the implementation of this notice in all health units in Ontario, would in effect not only eliminate this health hazard in those businesses, it would also create a level playing field for those businesses that are presently governed by a 100% smoke free workplace.

**BE IT THEREFORE RESOLVED** that we request that the Eastern Ontario Health Unit issue a similar notice of Health Hazard from second-hand smoke in indoor spaces to all businesses under its jurisdiction.

**BE IT FURTHER RESOLVED** that we encourage all health units in Ontario to take similar action.




