## **GENERAL CONSENT**

### **ADOPTION OF MINUTES**

The Minutes of the Regular Meeting of Council #25-2005 under date of Monday, May 9, 2005, and of the Special Meeting of Council #26-2005 under date of Monday, May 16, 2005, were presented for adoption. One correction was noted.

### **PRESENTATIONS**

#### **1. Essential Level Emergency Management Program**

Mrs. Suzanne Carrier-Armstrong Provincial Emergency Co-Ordinator presented a congratulatory letter signed by the Honorable Monte Kwinter, Minister of Community Safety and Correction Services and the Honorable Julian Fantino, Commissioner of Emergency Manager which formally acknowledged the City of Cornwall's accomplishment of attaining the Essential Level Emergency Management Program to which the requirements were required effective December 31, 2004.

Special recognition was given to Ms Lisa Harvey for her commitment and determination in meeting these requirements.

#### **2. Life Saving Recognition Certificate**

On Wednesday, April 6, 2005, at 4:10 p.m., a patron, Mrs. Monica McDonald, of the Ontario Motor Vehicle Licence Bureau at 113 Second Street collapsed without warning. The individual suffered sudden cardiac arrest, a condition where the heart abruptly stops beating and breathing ceases. Without hesitating, Mr. Mike Metcalfe, a staff member of the building and Denis Chaisson, a patron at the building, provided cardiopulmonary resuscitation (CPR) in attempts to revive the victim. Paramedics arrived within minutes to the scene and continued resuscitation efforts. Prior to leaving the scene with the victim, a regular heart beat and breathing had resumed. The victim went on to make a full recovery. Without the efforts of Messrs. Metcalfe and Chaisson in those crucial first seconds, the outcome may have been entirely different.

This evening, Norm Barrette, Manager, Emergency Medical Services Division, and Mayor Phil Poirier recognized Mr. Mike Metcalfe and Mr. Denis Chaisson with an award for the life they saved, while Mrs. McDonald looked on.

### **3. Cornwall SD&G EMS Provincial Certification**

Mr. Norm Barrette, Manager, Emergency Medical Services Division, presented to Mayor Poirier a Certificate issued by the Ministry of Health and Long-Term Care / Emergency Health Services Branch attesting that the City of Cornwall and S.D. & G. Emergency Medical Services has met the criteria for certification as required under the Ambulance Act and the Regulations and as authorized by the authority of the Director of Emergency Health Services Branch shall continue to provide Emergency Medical Services for a period of three years, which certificate expires on November 3, 2007.

### **4. Jim Brownell, M.P.P.**

Mr. Brownell briefed the Council as to his ongoing efforts in bringing forward those concerns to which the Council recently detailed in a letter addressed to him. An overview of issues such as compensation paid to the City for taxes owing on the RH Saunders Generating Station, advocating the Province in forgiving the City's loan on lands housing the Cornwall Square which monies would be better served to help revitalize the Downtown Business District. Mr. Brownell encouraged the Council not be discouraged on the recent announcements made as to the COMRIF funding and that it continue to submit proposals

Mr. Brownell indicated that he has been dialoguing on a weekly basis with the Minister of Finance in that his Ministry look favorably upon the City of Cornwall in forgiving an outstanding loan that would better serve the Downtown Revitalization project.

Mr. Brownell urged the Council to continue lobbying the Provincial Government in issues of importance to the City of Cornwall and that their concerns be provided to him in writing so that he would in turn present them to Caucus. In conclusion to the discussions, Mr. Brownell was thanked for taking time to visit and talk to the Council.

### **5. Financial Statement Review - 2004**

Ross Markell, Municipal Auditor, from the offices of Craig Keen Despatie Markell, Chartered Accountants, presented the Financial Statements for the year ending December 31, 2004.

Mr. Markell's firm audited the consolidated statement of Financial Position of The Corporation of the City of Cornwall as at December 31, 2004, and the Consolidated Statements of Financial Activities and Changes in Financial Position for the year then ended. These Financial Statements are the responsibility of the Corporation's management. The firm's responsibility is to express an opinion on these Financial Statements based on its audit.

It is Mr. Markell's opinion that these Financial Statements present fairly, in all material respects, the financial position of The Corporation of the City of Cornwall as at December 31, 2004, and the results of operations for the year then ended, in accordance with Canadian generally accepted accounting principles.

Mr. Markell briefly reviewed the City's Net Financial Assets and Liabilities and the Municipal's position as at year end 2004 and indicated that the City of Cornwall was in a very good financial position with a Net Financial Asset of \$36,670,088 compared to \$33,487,394 at year end of 2003.

It was mentioned that the two Reserve Funds established and its net proceeds were from the sale of Cornwall Electric. The balance held in the debt retirement reserve fund has been invested in financial instruments with maturity dates and values that match the repayment obligations of the net long-term liabilities and associated interest payments that are funded from the tax and to improve the quality of life for the residents of the City of Cornwall Activities during the year 2004 provided the City with a year end balance of \$38,360,219 remaining even after it met its financial commitment of \$5,900,000 funding promise to Project 2000 for the construction of the new aquatic centre in Cornwall.

Mr. David Dick, Manager, Financial Services, continued the presentation by summarizing the Financial Statement with a Power Point presentation.

Moved by Councillors Naresh Bhargava and Glen Grant that Council approve the 2004 audited Financial Statements as per Report FI #19-2005 prepared by David Dick C.A., Manager, Financial Services, under date of May 16, 2005. The report details that the City, following its annual audit, completed the year 2004 with an overall surplus of \$1,671,833. During the Council's 2005 budget deliberations, they approved the appropriation of \$1M from reserves (2004 surplus). The net result of these transactions are to increase working serves by \$214,231; water reserves by \$222,376 and the sewer reserve by \$235,226.00.
