## **2. Cornwall Community Police Service**

Deputy Chief Dan Aikman presented a report detailing expenses and fees totalling \$469,683.19 paid out by the Cornwall Community Police Service as of March 31, 2006, associated to the Cornwall Public Inquiry.

The Cornwall Public Inquiry was established by Order-in-Council dated April 14, 2005, to inquire into the institutional response of the justice system and other public institutions regarding allegations of historical sexual abuse of young people in the Cornwall area.

The Cornwall Community Police Services Board has retained the services of Mr. John Callaghan, of the firm Gowling Lafleur Henderson LLP to represent the interests of the Board and the Service at the Inquiry.

The demands of the Cornwall Public Inquiry have been such that it has impacted almost every aspect of the Cornwall Community Police Service. Deputy Chief Aikman and Staff Sergeant Derochie have been assigned to liaise with legal counsel and coordinate the response to Inquiry demands.

Since November 10, 2005, upwards of five Records Bureau staff have been engaged in the process of accumulating records on all Cornwall Community Police Service sexual assault investigations dating back to 1948. This has involved the accumulation of tens of thousands of documents, taking thousands of hours of staff time.

Virtually every serving Police Officer of the Service has provided notes or statements pertaining to the substance of the matters being examined by the Inquiry.

## **3. Cornwall Collegiate and Vocational School (CCVS) 200<sup>th</sup> Anniversary**

Brenda Beaudette, Principal, and Doug Searle, Vice-Principal, of Cornwall Collegiate and Vocation School stood before Council this evening and spoke about their upcoming preparations to the Bicentennial celebrations of CCVS .

Ms. Beaudette shared with Council members the significance of CCVS in the fabric of Cornwall and the surrounding area. On June 28, 2006, the school graduation will take place. Over 3,000 people are anticipated to attend the ceremony. This event is meant to celebrate the past, the present and the future, and Council members were invited to attend.

In conclusion, Ms. Beaudette requested Council's assistance with the financial cost in so far as a one time request to waive the fees applied to rental of the Cornwall Civic Complex facilities in order to accommodate the large volume of anticipated attendance of the 2006 graduation festivities.

## 5. Homestead Act

Moved by Councillors Glen Grant and Perry O'Shaughnessy

The private member's bill proposes a number of assessment and capping provisions be included in the Assessment Act. Although, the recent CVA has caused significant debate across the province, we need to remember that assessment plays only a portion of the tax charge to individual municipal taxpayers. The net municipal levy is the driving factor in municipal taxes and is a determinant of approved spending levels net of non tax revenues. Clearly, expenditures are increasing at rates considered to be beyond our ability to finance. A number of these increases are due to provincial regulations and mandates. As mentioned during our budget deliberations, the controllable component of our budget now stands at approximately 25% and is becoming smaller each year. Given the proper level of funding and controllable expenditures, one would expect that increasing assessments should be offset by decreasing tax rates leaving manageable tax increases. It should also be expected that the system should be relatively stable given the large increases experienced over the past few years
