#### **2. Marketing Plan for 2008 - Department Economic Development**

Mr. Bob Peters - Senior Economic Development Officer provided Members of Council with the 2008 Marketing Plan with three main areas of target: Communication meaning: How can we reach the people we need to reach?; Influence: What is important to our customers?; and Opinion; What do people think about our city?

The Marketing Vision is identified as: Cornwall having a clear identity where a modern city is one where people can succeed; Cornwall has a clear brand, where we are a city with a world of possibilities and Cornwall having a clear marketing goal, where the City is to increase its profile to key target markets.

The 2008 Marketing Plan, as indicated by Mr. Peters, is divided into eight main strategies being:

General Profile Advertising, Specific Sector Efforts, Marketing Materials, Internet, Signage, Sponsorship, Database Marketing and Media Relations.

General purpose advertising aimed at improving Cornwall's "Q Score" – the level of awareness that people have of the City. In addition, the new Marketing Plan aims its sector specific efforts in marketing materials and other efforts such as: Sponsorship, Database Marketing, Media Relations, Banners and Website. A new fully bilingual website aimed at attracting people to live in Cornwall is also being displayed.

**WHEREAS** Canada and Ontario have been holding discussions on the Building Canada Framework Agreement since late last year; and

**NOW THEREFORE**, Be it Resolved that the Governments of Canada and Ontario make a commitment to renewed, dedicated negotiations that will see a Building Canada Framework Agreement signed expeditiously so that Ontario's municipal governments can benefit from additional investment opportunities that a collaborative Canada-Ontario contribution agreement can bring to their significant infrastructure needs; and
