BY-LAW NO. 158-90 OF THE CITY OF CORNWALL

A bylaw to amend By-law No. 069,1989 as amended

\* \* \* \* \*

The Council of the Corporation of the City of Cornwall enacts as follows:

1. Section 51 of By-law no. 069,1989 is hereby repealed and replaced as follows:

*For the purpose of this part:*

- (1) *"designated parking space" means a parking space designated under this part for the exclusive use of a vehicle displaying a permit in accordance with the requirements of the Highway Traffic Act and the regulations made thereunder, and this part;*
- (2) *"municipal or private property" means any open area or portion of a structure, other than a street or highway, intended for the temporary parking of vehicles and on which there are designated parking spaces, whether their use involves the payment of a fee or otherwise;*
- (3) *"permit" means a disabled person parking permit issued under the Highway Traffic Act or a permit, number plate or other marker or device issued by another jurisdiction and recognized under that Act;*

2. Section 52 of By-law No. 069,1989 is hereby repealed and replaced as follows:

- (1) *A designated parking space shall be distinctly indicated in accordance with the requirements of the Highway Traffic Act and the regulations made thereunder.*
- (2) *Every owner or operator of a public parking area who chooses to provide designated parking spaces for the exclusive use of vehicles operated by or conveying physically disabled persons, upon which is displayed a valid disabled parking permit, shall ensure that the designated parking spaces be:*
  - (a) *a minimum of three (3 m) metres in width, subject to the provisions of subsection (3);*
  - (b) *of the same length as the other parking spaces in the same public parking area;*
  - (c) *hard surfaced;*
  - (d) *level;*
  - (e) *located so as to be readily accessible to physically disabled persons, whether via ramps, depressed curbs or other means, and, where the public parking areas is intended to serve a particular building or complex, located within easy access of said building or complex;*
  - (f) *identified by signs conforming to the requirements of the Highway Traffic Act; and*

- (g) signs required under subsection (2)(f) be mounted on a permanent post with the bottom of the sign a minimum of 1.2 m and a maximum of 1.8 m above ground level with said post to be located at the end of the designated parking space at a point marking the midpoint in width of the parking space or spaces.
  - (h) kept free from obstructions, kept clear of snow, and be otherwise maintained to the same standards as all other parking spaces in the same public parking area.
- (3) Every owner or operator shall provide on one side of each designated parking space, a space one point five (1.5 m) metres in width, running the length of each designated parking space. Said space shall be marked in a manner to prevent parking thereon.
  - (4) Notwithstanding other provisions of this Section, and only until November 1, 1991, signs designating reserved stalls may display the symbols and colours as shown in Schedule XXIII to this by-law, but provided that one or both of the arrows may be deleted from the signs.
  - (5) Every owner or operator of each public parking area in which signs are located pursuant to the Highway Traffic Act and this Section shall be responsible for the procurement, installation and maintenance of said signs, and for ensuring that said signs conform with the provisions of the Highway Traffic Act and this Section.
  - (6) The driver or operator of a vehicle which displays a permit in accordance with the requirements of the Highway Traffic Act and the regulations made thereunder and this bylaw shall not be required to pay an amount in excess of the normal fee paid by other users of the same parking lots or other parking facilities to which the public has access.
3. Section 53 of By-law No. 069,1989 is hereby repealed.
4. Section 54 of By-law No. 069,1989 is hereby repealed and replaced as follows:
- (1) No person or organization shall:
    - (a) park a vehicle in a designated parking space, or
    - (b) be entitled to the benefit of an exemption under this bylaw,unless a currently valid permit has been issued to that person, organization or to a passenger being picked-up or transported in the vehicle and such permit is displayed on or in the vehicle in accordance with the requirements of the Highway Traffic Act, the regulations made thereunder and under Section 55 of this part.
  - (2) The provisions respecting the placement of a valid parking permit for the physically disabled referred to in subsection (1) hereof shall be deemed to be satisfied if a valid physically disabled permit is placed on the dashboard of the motor vehicle at the request of a Police Officer, Provincial Offences Officer, or a public parking area owner or operator.
  - (3) Neither public parking area owners nor operators shall authorize any person, other than a physically disabled person or a person conveying a physically disabled person, to park a motor vehicle in any space reserved for physically disabled persons.
  - (4) No person, other than the person to whom it was issued or a person conveying the person to whom it was issued, shall use or display a parking permit for the physically disabled issued to a physically disabled person to enjoy the privileges or avoid the restrictions set out in subsection (1) hereof.

(4) Municipal parking lots leased to and operated by the Downtown Merchants Board of Management are hereby designated as attendant parking zones.

3) Section 21 of Bylaw No. 069-1989 is hereby repealed and replaced as follows:

## Method of Use - Payment

21. (1) Where parking meters have been installed under the authority of this by-law, no person shall park a vehicle, or permit a vehicle to remain parked in a parking meter space within a parking meter zone or municipal parking lot unless the owner or operator of said vehicle, upon entering the said parking space:

(a) immediately deposits the required money in the parking meter alongside of or next to the said parking space; and

(b) activates the parking meter by turning the handle to indicate the unexpired time paid for in accordance with the hourly rate.

(1a) The hourly rate referred to in subsection (1) (b) shall be the rate indicated on the meter rate plate affixed to the meter nearest the parking space; and/or on the information plate affixed to the face of the "pay-and-display" machine; and/or as indicated on parking lot signage.

(1b) Compliance with subsections (1) and (4) of this section shall apply on:

Mondays, Tuesdays, and Wednesdays,  
between the hours of 9:00 a.m. and 6:00 p.m.

Thursdays and Fridays  
between the hours of 9:00 a.m. and 9:00 p.m.

except holidays.

(2) The provisions of subsection (1) shall not affect the privilege of the owner or operator of a vehicle of using the unexpired time as indicated on a parking meter.

(3) Within an attendant parking zone, no person shall park a vehicle or permit a vehicle to remain parked unless the owner or operator of said vehicle obtains an authorized ticket upon which the time of entry into said attendant parking zone is clearly indicated.

(4) Where a "pay-and-display" machine has been installed under the authority of this by-law, no person shall park a vehicle, or permit a vehicle to remain parked in a parking meter space within a municipal parking lot unless the owner or operator of said vehicle, upon entering the said parking lot:

(a) immediately deposits the required money in the "pay-and-display" machine controlling the parking meter space as indicated by signs;

(b) displays the valid and unexpired ticket issued by the "pay-and-display" machine clearly in sight, face up, on the left side of the front dashboard of the vehicle parked in said parking meter space, and in such a manner as to clearly show the parking lot name, date, and expiry time.

4) Section 22 of Bylaw No. 069-1989 is hereby repealed and replaced as follows:

*Bylaw 163-1995*

Time Limits

22. (1) Where parking meters or a "pay-and-display" machine have been installed under the authority of this by-law, no person shall park a vehicle, or permit a vehicle to remain parked in a parking meter space within a parking meter zone or municipal parking lot for a period of time in excess of the indicated time limit.
- (1a) Legal parking time limit referred to in subsection (1) shall be that time limit indicated: on the meter rate plate affixed to the meter nearest the parking space; and/or on the information plate affixed to the face of the "pay-and-display" machine; and/or as indicated on parking lot signage.
- (1b) Payment of the rate indicated as per Section 21 shall entitle the operator of a vehicle to park for the amount of time indicated next to the rate on the meter rate plate; and/or as indicated on the information plate affixed to the face of the "pay-and-display" machine; and/or as indicated on parking lot signage, subject to the provisions of Section 21 and this section.
- (1c) Compliance with subsection (1) of this section shall apply on:
- Monday, Tuesdays, Wednesdays and Saturdays between the hours of 9:00 a.m. and 6:00 p.m.  
Thursdays and Fridays between the hours of 9:00 a.m. and 9:00 p.m.
- except holidays.
- (2) Within a municipal parking lot or attendant parking zone, no person shall park a vehicle, or permit a vehicle to remain parked for a period of time in excess of twelve (12) hours
- (3) No person shall park a vehicle, or permit a vehicle to remain parked within an off-street parking meter zone or attendant parking zone in such a way as to interfere with the plowing or removing of snow or any other maintenance work undertaken by or on behalf of the Corporation.
- (4) Where a "pay-and-display" machine has been installed under the authority of this by-law, no person shall park a vehicle, or permit a vehicle to remain parked in a parking meter space within a parking lot on which an expired ticket is displayed.

5) Section 23, subsection (2) of Bylaw No. 069-1989 is hereby repealed and replaced as follows:

- (2) No person shall park a vehicle or permit a vehicle to remain parked in such a manner that it is not wholly within the area designated as a parking space unless the vehicle is of such length as to render it impossible to park it in one (1) parking space, in which case the adjoining parking space or spaces may, in addition, be used if the required coin deposits are made in the parking meters provided for all parking spaces used by the vehicle, and in compliance with all other sections of this by-law.

6) Section 25 of Bylaw No. 069-1989 is hereby repealed and replaced as follows:

Monthly Parking Permits

25. (1) Section 21 (1) of this by-law shall not apply to a motor vehicle having an overall length not exceeding 6.0 meters (19.7 feet) provided that such vehicle is parked:

- (a) at a meter displaying a legal time limit in excess of three (3) hours; or
- (b) within a designated area of an attendant parking zone, as indicated by signs; or
- (c) within a designated area of a municipal parking lot controlled with a "pay-and-display" machine, as indicated by signs,

subject to the provisions of subsections (2) and (3).

(2) A Monthly Parking Permit, issued by the Corporation of the City of Cornwall, valid for the current month, must be displayed:

- (a) against the driver's side of the windshield; or
- (b) attached to the rear view mirror of the vehicle in the case of a permit so designed.

- (3) If for any reason such as a broken windshield or the sale of the vehicle, the person to whom the original permit was issued under subsection (1) can produce the old permit or pieces of it, a new or replacement permit may be issued at a cost of Five (\$5.00) Dollars.
